1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

1.1. Application and Definitions

- 1.1.1. These Rules shall apply to all Community Competition Fixture(s) and Sanctioned Match(es) as defined in Rule 1.1.5.
- 1.1.2. If any provision of these Rules is held invalid or unenforceable by a court of competent jurisdiction then the remainder of these Rules and the application thereof shall not be affected thereby and shall continue to be valid and enforceable to the fullest extent permitted by law.
- 1.1.3. These Rules shall be subject to amendment in FV's absolute discretion, including where required as a result of Government regulation(s). If these Rules are amended for any reason, FV will take reasonable steps to notify Clubs of the amendment(s).
- 1.1.4. Terms defined in the FV Constitution, 2023 FV Registration Regulations and/or the GDT shall have the same meaning in these Rules unless otherwise stated.
- 1.1.5. In addition to Rule 1.1.4 unless the context otherwise requires, the following definitions apply:
 - a. **Abandoned** means a Competition Fixture which has failed to commence for any reason or has commenced but has been stopped by the Match Official prior to its conclusion in accordance with Rule 4.2.
 - b. **Competition Regulations** or **Regulations** means the regulations which supplement these Rules, and which apply to the competitions administered by FV (other than NPL) for Men's Football, Women's Football, Junior Football and Metro & Masters Football, as amended and updated by FV from time to time.
 - c. **Club** has the same meaning as in the FV Constitution and includes but is not limited to a Futsal Club.
 - d. **Club Associate(s) or Club Official(s)** has the meaning given to it in the GDT.
 - e. **Competition Fixture** means any match that is administered by FV and includes matches to which FV appoints Match Official(s).
 - f. **Community Competition** means competitions administered by FV (other than NPL) for Women's Football, Men's Football, Junior Football and Metro & Masters Football, as amended and updated by FV from time to time.
 - g. **Cup Fixture** means any knock-out cup match, fixture or other event organized and/or administered by FV or FA before, after or in conjunction with a Regular Season and includes, but is not limited to, the Dockerty Cup, Australia Cup and Women's State Knockout Cup (currently the Nike F.C Cup).
 - h. **Default Notice** means a notice of default issued by FV in relation to an amount owed to FV by a Club or a player which that Club or player has failed to pay in accordance with Rule 1.3.
 - i. **Division** means a particular grade or level of men's or women's competition within Victorian Football (e.g. Men's State League 1 or Women's State League 3 or Men's Metropolitan League 3).

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- j. **FA** means Football Australia
- k. **FV** means Football Victoria.
- l. **Field of Play** means:
 - (i) At an enclosed pitch the entire area within the temporary or permanent perimeter fencing; or
 - (ii) At an open pitch the entire area within 3 metres of the boundary line of the football pitch.
- m. **Final** means a Competition Fixture played to determine the champion of a Finals Series administered by FV.
- n. **Forfeit** means failure to participate in a Competition Fixture.
- o. **Futsal Club** means a Club which plays in a futsal competition administered by FV.
- p. **GDT** means the FV Grievance Discipline and Tribunal By Law (as amended from time to time)
- q. **Goal Difference** means the difference between goals scored by a Club/Team (Goals For) and goals scored against a Club/Team (Goals Against) in a match or season.
- r. **Home Club** means the Club named first in a Competition Fixture.
- s. **Host Club** means a Club which hosts one or more Competition Fixtures or Finals at its home venue, whether or not that Club participates in one of those Competition Fixtures or Finals or not.
- t. **IFAB** means International Football Association Board.
- u. **League** (when referred to Men's or Women's football) means a particular competition within a Division (such as Men's State League 1 South-East or Women's State League 3 North or Men's Metropolitan League 3 North-West).
- v. **Match Official** means a match official as defined in the GDT.
- w. **Match Record** means the official log (hard copy or online) of the Competition Fixture recording all match details including participants and results.
- x. **Misconduct** has the meaning given to it in the GDT.
- y. **No Result** means recording a '0-0' score line in a Competition Fixture with no points or goals awarded to either Team. A 'No Result' is recorded as a Competition Fixture played.
- z. **Non-Participation in a Fixture** means failure to participate in a Competition Fixture having notified FV more than three (3) days prior to the Competition fixture.
- aa. **Normal Time** means the maximum length of two (2) equal periods not including added time as specified in Rule 4.1 and Table 4.1 unless any time reduction is otherwise determined in accordance with Rule 4.1.
- bb. **NPL** means National Premier Leagues (Victoria).

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

cc. **Play Off Match** means a Competition Fixture played to determine the final standings of a League or the eligibility for promotion/relegation of a Team between Leagues or Divisions.

dd. **Played** means:

(i) A Team has participated in a Competition Fixture.

In specific reference to a player, **Played** means:

(ii) Being listed on the Match Record in a League where the interchange rule applies; or

(iii) Starting the Competition Fixture on or consequently being substituted onto the Field of Play in a League where the substitution rule applies.

(iv) If a player is originally listed on the Match Record and it is subsequently indicated on the Match Record that the player is no longer to participate in the Competition Fixture, that change must be acknowledged by signature of the senior Match Official prior to the commencement of the Competition Fixture. Failure to comply will deem the player to have 'Played' that fixture under Rule 1.1.5.cc.

ee. **Player ID Card** means the Play Football generated ID card containing recent photo, date of birth, FA number, full name, and Club name for that player.

ff. **Postponed** means a Competition Fixture which has not commenced as scheduled.

gg. **Registered** means registered and eligible in Play Football in accordance with the 2023 FV Registration Regulations.

hh. **Regrading Result** means a result which has been attributed due to a team that has been regraded into a Competition.

ii. **Regular Season** means the time and Competition Fixtures between the first and last round of the relevant competition or as otherwise determined by FV acting in its absolute discretion, in addition to any Play Off Match(es) required for the purpose of promotion and relegation.

jj. **Rule** or **Rule of Competition** means a rule set out in a clause or clauses of these 2023 Rules of Competition.

kk. **Risk Assessment and Security Policy** is the FV policy which outlines minimum security requirements and responsibilities at Competition Fixtures.

ll. **Sanctioned Match** means any match to which FV appoints one (1) or more Match Official(s) but does not administer directly. This includes matches to which FV is unable to appoint one (1) or more Match Official(s) due to availability, but a request for appointment has been made and acknowledged.

mm. **Team** means a football team entered by a Club in a League or, in junior football (U7s to U21s) a team entered by a Club in a competition, administered by FV.

nn. **Technical Area** is as defined in the Minimum Facility Requirements set out in Schedule 3.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- 1.1.6. Decisions made by FV under these Rules are final, binding and unless stated to the contrary, not capable of being appealed.

1.2. Consequences of Breach

- 1.2.1. In addition to any consequences stated in the Rules or Regulations, any proven breach of or failure to comply with an obligation or requirement set out in these Rules or Regulations may amount to Misconduct and if so shall be subject to the provisions of the GDT.
- 1.2.2. To avoid doubt, where these Rules or Regulations do not specify the consequences of a breach or failure to comply with these Rules or Regulations, such breach or failure to comply may still amount to Misconduct and if so shall be subject to the provisions of the GDT.

1.3. Monies Owing to FV

Monies Owing by a Club

- 1.3.1. All amounts owed by a Club to FV must be paid within 30 days of the date of the invoice issued by FV in relation to that amount or such sooner time required under the GDT or stipulated by FV.
- 1.3.2. If a Club fails to pay any amount owing to FV in accordance with Rule 1.3.1, FV may issue a Default Notice giving the Club a further 14 days or less as stipulated by FV to pay that amount.
- 1.3.3. If a Club fails to comply with a Default Notice issued in accordance with Rule 1.3.2, or agree to a repayment plan with FV for the amount owed, FV may, at its absolute discretion:
- Rule that Club (or the applicable Team(s) within that Club) ineligible to earn competition points in any Competition Fixture or Sanctioned Match in which the Club (or Team) plays, until the debt is paid.
 - Suspend or expel that Club (or Team(s)) from any Competition Fixture (including Cup Fixtures) and/or FV competitions.
 - Prohibit that Club (or Team(s)) from promotion whilst the debt remains unpaid.
 - Relegate that Club (or Team(s)) while the debt remains unpaid.
 - Deduct championship points from a Club (or Team) for the current season where the debt remains unpaid.
 - Deduct championship points from a Club (or Team) for the following season where the debt remains unpaid or accrues after 31 October of the relevant year.
- 1.3.4. If FV and a Club agree to a repayment plan in relation to a debt owed by the Club to FV and the Club fails to meet any of the terms of that payment plan by the stipulated date and time, FV may immediately and without the need to issue a further Default Notice, impose one or more of the sanctions referred to in Rule 1.3.3.

Monies Owing by a Player

- 1.3.5. All amounts owed by a player to FV must be paid within 30 days of the date of the invoice issued by FV in relation to the amount payable or such sooner time as required under the GDT.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- 1.3.6. If a player fails to pay any amount owing to FV in accordance with Rule 1.3.5, FV may issue a Default Notice giving the player a further 14 days to pay that amount.
- 1.3.7. If a player fails to comply with a Default Notice issued in accordance with Rule 1.3.6 or agree to a repayment plan with FV for the amount owed, FV may, at its absolute discretion, suspend that player from any or all FV competitions or representative Teams on such terms as it sees fit until such debt is paid or secured to the satisfaction of FV.
- 1.3.8. FV may offset any monies owed by FV to a Club or a player against any amount owed by a Club or a player to FV prior to the issue of an invoice to a Club or player for amounts owing to FV.

1.4. Registrations, Forfeits and Abandonments

Definitions

1.4.1. For the purposes of this Rule:

- a. **Change of Status** has the same meaning as in the FV Registration Regulations.
- b. **Dual Registration** has the same meaning as in the FV Registration Regulations.
- c. **Field** means to record a player's name on the Match Record and "Fields" and "Fielded" have corresponding meanings.
- d. **Ineligible** means a player who is one of the following:
 - (i) Playing for the wrong Club or Team;
 - (ii) Playing within a stand-down period due to Change of Status;
 - (iii) Playing while registered for two clubs at the same time without a Dual Registration exemption to do so;
 - (iv) Playing while not Registered;
 - (v) Playing while under Suspension under the GDT;
 - (vi) A player who has been shown a red card earlier in a fixture that is still being played;
 - (vii) Playing while ineligible to do so for any other reason determined by FV; or
 - (viii) A Player or Players in breach of Rule 2.2;
- e. **Offence** means when FV has found upon investigation, audit, processing, or notification there has been a breach of this Clause including any of the previous fixtures in which an Unregistered or Ineligible Player(s) has participated.
- f. **Register** and **Registered** means a player who is registered in accordance with the applicable FV Registration Regulations, and/or FA National Registration, Status and Transfer Regulations, including without limitation seeking an International Transfer Clearance (ITC) where applicable.
- g. **Request for information** refers to where from time to time FV may request that a Club provide to it information in relation to player registration matters or otherwise as reasonably requested to ensure the integrity of football.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- h. **Unregistered** means a player who is not Registered.

Registration – Scope and Penalties

- 1.4.2. All Clubs and Teams must Register all Players in accordance with the FV Registration Regulations.
- 1.4.3. FV may find Unregistered or Ineligible Player(s) through random audits, daily processing or upon investigation following notification of a breach of these Rules.
- 1.4.4. Where a Club or Team Fields an Unregistered or Ineligible Player in a Competition Fixture, including Finals or Play-Off Matches, the following applies:
- a. A Team that is found to have fielded an Unregistered or Ineligible Player(s) during a Competition Fixture(s), the score for the respective Competition Fixture(s) must be amended as follows:
 - (i) where that Team loses the Competition Fixture, the result is the greater, in terms of score margin, of the actual score or a 3-0 result.
 - (ii) where the score is a draw that Team is deemed to have lost the Competition Fixture 3-0; or
 - (iii) where that Team wins the Competition Fixture, the result is a 3-0 win to the non-infringing Team.
 - b. Notwithstanding Rule 1.4.4 a above, where FV finds that a Club or Team has Fielded Unregistered or Ineligible Player(s) in multiple Competition Fixtures over a period of time, FV may in its absolute discretion:
 - (i) deduct competition points from the Team, capped at 12 points, without altering any of the corresponding individual Competition Fixture results; or
 - (ii) reverse such Competition Fixture results 3-0 as necessary
 - c. Matters that FV may take into account in making a decision under Rule 1.4.4b above include, but are not limited to:
 - (i) whether or not in FV's opinion the Unregistered or Ineligible Player(s) was intentionally or inadvertently Fielded;
 - (ii) whether a genuine administrative error occurred;
 - (ii) whether the Club made any enquiries to FV about the Player(s) prior to the Competition Fixture;
 - (iii) the experience of the Team or Club administrator;
 - (iv) the age-group affected; and/or
 - (v) any other factors FV may consider relevant in the circumstances.

By way of example: where FV learns in round 9 of a season that an U14 Team has inadvertently failed to correctly register a Player, rather than automatically deduct 27 points from that Team and reverse 9 Competition Fixtures, FV may either deduct up to 12 points from the Team and not reverse any individual Competition Fixtures, or reverse such Competition Fixtures as necessary.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- 1.4.5. Where FV learns of an Unregistered or Ineligible Player(s) via internal audits, and no Club or Team has raised a formal protest about those Players within the time set out in the next sub-clause, FV may deal with the matter via a warning and reprimand for the first occasion in its absolute discretion. The matter is then considered finalised (see *Additional Notes* section below).
- 1.4.6. The time limit for a Club or Team to Protest from the date of the relevant Competition Fixture, after which the result of the Competition Fixture is considered finalised, is:
- a. the time limit specified in these rules of competition for the relevant competition; or
 - b. if there is no such time limit specified, seven calendar days.

Note on Rule 1.4.6. it is important for the integrity of the competition and league that the results of Competition Fixtures are considered final. The intention of this Clause is to prevent teams from "saving up" suspicions of Unregistered or Ineligible Players in other teams until shortly before finals, in order to make a last effort to accrue points for finals. Legitimate concerns by a team should be notified to FV promptly.

Additional notes: in state league junior football for U12s to U15s inclusive and junior metro football, the focus is on participation. Where Unregistered or Ineligible Player(s) in these leagues are identified, FV will favour an interpretation of a genuine administrative error unless it can be shown that the Unregistered or Ineligible Player(s) were played intentionally. However, in NPL leagues, or other state league or metro competitions, FV's expectation is for greater administrative compliance by Clubs, and participation by Unregistered or Ineligible Player(s) in these competitions may be interpreted against the Club or Team more stringently.

System or Technical Error

- 1.4.7. To avoid doubt, if there is a system or technical error in processing a registration, the above sanctions will be imposed until such system or technical error is proven by the Club or Team or Player, save that:
- a. only those system or technical errors that occur on weekdays up until 5.00pm on a Friday, (excluding Public Holidays) will be taken into account; and
 - b. should a Club or Team decide to process registrations on non-business days (Weekends and/or Public Holidays) or after 5.00pm on a Friday, the Club or Team is responsible for ensuring all registrations are successfully processed and valid for all Club and team fixtures.

Forfeits

- 1.4.8. Clubs must notify FV as soon as practicable in advance in the event that they are unable to participate in a Competition Fixture.
- 1.4.9. A Forfeit occurs when a Club or Team fails to participate in a Competition Fixture.
- 1.4.10. In the event of a Forfeit, the forfeiting Team:
- a. is deemed to have lost the Competition Fixture 3-0; and
 - b. will receive a forfeit notice from FV;
- 1.4.11. Any Team which incurs Forfeits in four (4) Competition Fixtures within a Regular Season may be removed from its League at FV's absolute discretion.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

Request for Information

- 1.4.12. Where FV requests a Club to provide information in relation to a Club's registration matters, or otherwise as reasonably requested in order to ensure the integrity of football, the Club must comply within 7 days (or as otherwise reasonably requested by the FV).
- 1.4.13. A failure to comply with Rule 1.4.8 above results in all of that Club's teams playing for no points until the requested information is provided. Should a Club subsequently comply with Rule 1.4.8 above, any games which were played for no points during the non-compliance period will not be replayed, and any points lost are deemed as forfeited.

Registration of Coaches and Team Officials

- 1.4.14. Clubs are required to submit Registration for all Coaches and Team Officials whom they appoint to Teams including but not limited to:
 - (i) Coaches (Head Coach, Assistant Coach, Goalkeeper Coach etc.)
 - (ii) Technical Directors;
 - (iii) Physiotherapists; and
 - (iv) Team Managers
- 1.4.15. The Registration can be completed by each Coach or Team Official Self - Registering via Play Football, and the Club accepting the Coach or Team Officials Registration.

1.5. Protection of Important Fixtures

- 1.5.1. Where an A-League Mens, A-League Womens, International or an Inter-State match is scheduled in the State of Victoria, FV may determine that no other Competition Fixture or Sanctioned Match take place at the same time.

1.6. Sanctioned Matches

- 1.6.1. Any Club taking part in a Sanctioned Match must abide by any and all codes of conduct or codes of behaviour prescribed by FV and/or FA from time to time, including the Codes of Behaviour attached to these Rules at Schedule 5.
- 1.6.2. By participating in a Sanctioned Match, the Club and any League or association to which that Club belongs, submits to the jurisdiction of FV, its Rules and Regulations and the GDT.
- 1.6.3. Any Club or Team, association or organisation which administers or participates in any Sanctioned Match, must ensure that appropriate insurance and Work Cover arrangements are made to provide adequate and necessary coverage for their players, Match Officials, and all club associates involved in Sanctioned Matches.
- 1.6.4. Any Club or Team, association or organisation wishing to participate in any interstate or international match, tournament or event must apply in accordance with the 2023 FV Registration Regulations, writing to the FV Play Football Team for prior approval.
- 1.6.5. All Competition Fixtures take precedence over non-FV matches or fixtures or tournaments. Failure to fulfil Competition Fixtures for a non-FV match or fixture may result in disciplinary action in accordance with Rule 4.6.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

1.7. Insurance

- 1.7.1. FV will negotiate and appoint an insurance company or companies to provide cover for all Club Associate and/or Club Officials and players registered with FV as it sees fit, provided Clubs are incorporated at all times.

Insurance of Players

- 1.7.2. All players taking the field of play (or training) must be insured through FV's Insurer (or as otherwise allowed by FV). Each player's insurance premium will be collected by FV at the time of player payment for registration via the Club Finance System (refer to the Summary of Cover as posted on the FV Website for policy details).

Insurance of Club Associates and officials

- 1.7.3. In addition to compulsory player insurance, FV shall provide through its insurance scheme, insurance known as 'Not for Profit Organisation Liability' for Club Associates and Club Officials.

1.8. Strict Liability of Clubs

- 1.8.1. Each Club shall be responsible for the conduct of its Club Associates and Club Officials at or in the vicinity of any Competition Fixture, Sanctioned Match or non-FV event in which a Club is engaged or is in attendance regardless of the responsibilities attaching to any other person or entity in respect of such a match or event.

1.9. Club Name or New Club Name Application

- 1.9.1. An application for either a new Club name or the change of an existing Club name must be made by the relevant Club in accordance with the [FA Inclusivity Principles for Club Identity](#) as published on the FA website.
- 1.9.2. FV will only assess an application under Rule 1.9.1 when all relevant information has been lodged with FV. FV may reject an application for a new name or a change of name as it sees fit.
- 1.9.3. The reference to 'Club name' in this Rule 1.9 includes the incorporated name, registered business name and/or approved playing name of a Club.
- 1.9.4. Process for new name application by a Club:
- All submissions will be considered in accordance with [FA Inclusivity Principles for Club Identity](#)
 - The Club name must be approved in writing by the local government authority and be representative of the geographic area within which the Club is located.
 - Club name approval by FV and/or FA will at all times be subject to the Club holding any applicable legal right(s) to use that name and any associated logo. It is a Club's sole responsibility to ensure that it holds any applicable legal rights.
 - The Club must:
 - Submit its request for a change of Club name or new Club name on Club letterhead with a completed [NRR02B](#) form
 - Provide full disclosure of the reasons for the requested change.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- (iii) include a minimum of three (3) proposed names with their application for change of Club name or new Club name that can be assessed, and comply with Rule 1.9.4.d.(iv).
 - (iv) Receive written approval by local government authority and ensure that their proposed names are representative of the geographic area within which the Club is located.
 - (v) Subject to Rule 1.9.4.e., the new Club name must not contain any part of the name of any Club in the same or immediately adjoining municipalities, excepting the following traditional generic football names:
 - United
 - Rovers
 - City
 - Old
 - Sporting
 - e. FV may, at its absolute discretion, permit a new Club name to share a similar geographic reference to an existing Club name within the same or adjoining municipality if, in FV's opinion, the new Club (and its name) will not negatively impact any existing Club.
 - f. Where a change of name also involves a Club proposing to relocate to a different local government municipality, the application for change of name will not be considered unless evidence is provided to FV that there are no outstanding debts or other obligations to the former council/municipality.
- 1.9.5. FV will not approve the relocation of a Club to a different municipality unless it is in the best interests of Victorian football in general (to be determined at the absolute discretion of FV) and no existing Club in the municipality to which the relocating Club wishes to move is materially disadvantaged (to be determined at the absolute discretion of FV).
- 1.9.6. Where a Club requests to move to a geographic location different to that which its current name suggests, FV may require the Club to submit a new request for a change of Club name in line with these Rules.
- 1.9.7. No Club is permitted to have more than one (1) incorporated name or registered business/playing name.
- 1.9.8. *Incorporation*
- A Club must provide FV with documentary evidence of registration of any new name with the appropriate government authority. Failure to provide evidence in accordance with this Rule may result in previous approval by FV and/or FA of a new club name or a club name change being revoked.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

1.10. Ticketing and Refunds of Money

- 1.10.1. Ticket prices must be clearly displayed at the venue entry point and ticket box at all Competition Fixtures where admission fees are charged.
- 1.10.2. Clubs that charge admission fees must hand over an admission ticket to the paying customer when the exchange of money is made.
- 1.10.3. It is the customer's responsibility to ensure that he or she retains proof of purchase.
- 1.10.4. Customers that present an authentic FA or FV Pass, Match Official Pass or are aged 14 years or younger, will be granted free entry to Competition Fixtures and do not require an admission ticket unless otherwise communicated by FV (for example in relation to Finals or Playoffs).
- 1.10.5. A copy of Rule 1.10 is to be displayed at the ticket box at all venues where admission fees are charged.
- 1.10.6. Paying customers will be entitled to a full refund (including car park fees) on the day of the Competition Fixture if the main Competition Fixture on the day has been postponed or abandoned prior to the conclusion of the first half of that fixture.
- 1.10.7. To be eligible to receive a full refund in accordance with Rule 1.10.6 the customer must present to the Home Club or the Host Club charging admission fees or FV in the instance of Finals, the admission ticket (or part thereof) issued in accordance with Rule 1.10.2.

1.11. Security at Home Pitches

- 1.11.1. The Home Club is responsible for providing appropriate arrangements to ensure the orderly behaviour of spectators and provide protection for Match Officials, players and Club Associates and officials at Competition Fixtures including but not limited to any specific requirements of FV which are notified to the Home Club.
- 1.11.2. All Clubs, players, Match Officials, Club Associates and Club Officials must comply with [FV's Match Day Risk & Security Policy](#) as promulgated by FV, and any security arrangements put in place as a result of the application of that policy.
- 1.11.3. Each Home Club is responsible for security and/or police as directed by FV. Ordinarily this will be wholly the responsibility of the Home Club but FV reserves the right to require any Club involved in a Competition Fixture to meet FV determined security requirements in accordance with Rule 1.11.2 or as otherwise determined by FV.
- 1.11.4. Home Clubs and Host Clubs must provide a lockable facility for all valuables of Match Officials(s) and participating Clubs. Failure to provide such a facility may result in the Home Club or Host Club not being allocated Competition Fixtures at their home ground.
- 1.11.5. Rules 1.11.1 – 1.11.4 apply to a Club's home ground or facility and any neutral ground or facility (including the State Football Centre at Darebin and the Knox Regional Football Centre) where that Club is listed as the Home Club for the purposes of a Competition Fixture to be played at the neutral ground or facility.
- 1.11.6. The Home Club or the Host Club will be held responsible if it is found that Match Official(s) do not receive all personal items back.
- 1.11.7. Each Club is responsible for the valuables of its players, and valuables that are left in change rooms are done so at the owners' personal risk.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

- 1.11.8. Rule 1.11. is subject to FVs Risk Assessment and Security Policy which may be amended from time to time.

1.12. Representative Teams

- 1.12.1. Any player registered in Victoria will be eligible to represent Victoria in representative matches, camps or tours and each selected player must make themselves available for training, preparation and participation for representative matches, camps or tours when requested by FV.
- 1.12.2. All Clubs must release players for training and preparation for, and participation in, representative matches, camps, or tours.
- 1.12.3. Where a Club has four (4) or more outfield players or two (2) goalkeepers from the same Team participating in an FV/FA approved representative match, camp or tour which conflicts with a Competition Fixture in which that Club or Team is required to participate, the Club may seek postponement of that Competition Fixture. Approved representative matches may include but are not limited to:
- a. FA National Championships
 - b. FV State Teams
 - c. National Teams
- 1.12.4. All requests pursuant to Rule 1.12.3 must be received no less than 10 days prior to the Competition Fixture in question, unless the player is called up within the 10-day period by FV/FA for representative duty. FV shall determine the outcome of any request under this Rule at its absolute discretion and that decision cannot be appealed or reviewed.

1.13. Member Protection

- 1.13.1. FV has adopted the FA National Member Protection Policy and Framework (MPP) for all FV affiliated competition administrators, Clubs, Players and Club Associates and Match Officials. The MPP can be found by clicking the following [link](#).
- 1.13.2. FV has partnered with Proud2Play and Pride In Sport in order to eradicate discrimination, particularly against those who identify as gay, lesbian, bisexual, transgender and intersex. We have also updated [FV Dispensation Policy](#) which provides clear and concise process to dispensation requests. Dispensation requests allow Clubs to submit a request for a player/s to be granted exemption from FV to participate in competitions that they would otherwise not be eligible.
- 1.13.3. FV has a direct relationship with the Australian Human Rights Commission, Victorian Multicultural Commission and the Victorian Equal Opportunity and Human Rights Commission in order to call on these expert organisations to receive advice, and deal with issues that will assist FV to eradicate race and ethnic based discrimination.
- 1.13.4. Football Victoria partners with Sport and Recreation Victoria (SRV) to run a range of diversity and inclusion programs to make football for all. These include programs such as the All Abilities Program, GO Deadly and GO Proud programs.
- 1.13.5. FV welcomes and fosters diversity in the world game. All persons, Clubs, Players, Match Officials and/or Stakeholders involved with football are mandated to promote and provide safe and inclusive environments for all.

1. GENERAL MATTERS APPLICABLE TO ALL COMPETITIONS

1.14. Club Compliance and National Club Accreditation

- 1.14.1. In order to be eligible to compete in FV competitions in 2023 a Club must comply with the requirements set out by the following:
- a. Any Club compliance program;
 - b. [FV's Club Compliance Policy](#);
 - c. The [National Club Accreditation Scheme \(NCAS\)](#) criteria;
 - d. Consumer Affairs Victoria;
 - e. Australian Securities and Investment Commission (as applicable);
 - f. any other relevant regulator or Government body.

1.15. Correspondence / Communication

- 1.15.1. All correspondence sent by FV to Clubs shall be deemed to have been received by Clubs:
- a. In the case of online communication, the day on which it was published online.
 - b. In the case of email communication, the time at which it was sent.
 - c. In the case of communication sent by mail, two (2) business days after such communication was posted.
- 1.15.2. Clubs must ensure that their postal mailboxes, specified email accounts (including Spam and Junk folders) and the FV website are checked regularly, and that any information received is forwarded to the addressee or relevant parties within the Club.
- 1.15.3. All correspondence relating to Club requests, including, but not limited to; Competition Fixtures, forfeits, grading, result disputes and disciplinary matters must be made by a Club representative listed on Play Football. Requests made by anyone not listed as a Club representative in Play Football may not be actioned by FV.
- 1.15.4. All Clubs must have an active email address and phone number and ensure that this address and phone number and all other relevant details are current, up to date in Play Football and checked regularly by Club Associates and/or Club Officials.
- 1.15.5. Failure by a Club to keep a current, active email address and phone number and to check that email address and any voicemail service connected to its phone number regularly, cannot be relied on by the Club in relation to the question of whether or not notice of any matter was received by the Club from FV or otherwise.
- 1.15.6. FV reserves the right to only communicate with nominated club contacts as listed on PlayFootball.

1.16. COVID-19 Protocols and Regulations

- 1.16.1. All Clubs competing in FV Competitions and their Club Associates must comply with the COVID-19 Return to Training/ Play Conditions as published on the FV website and updated from time to time <https://www.footballvictoria.com.au/return-conditions>.
- 1.16.2. All Clubs competing in FV competitions are subject to and must adhere to the [Covid 19 Rules – Impacted 2023Community Competitions](#) as published on the FV website and updated from time to time.

2. COMPETITION RULES

2. COMPETITION RULES

2.1. General Information

- 2.1.1. All Competition Fixtures are played under the IFAB Laws of the Game, unless otherwise specified in these Rules.
- 2.1.2. Only Teams from FV Clubs, regional affiliates or representative Teams may enter FV competitions.
- 2.1.3. If a Team is withdrawn on or before the point of the Regular Season at which all Teams have played each other once a 'BYE' will be inserted to replace the withdrawn Team in the fixture. All championship points along with goals scored (for & against) for that Team will be erased. All Best & Fairest votes gained in Competition Fixtures involving the withdrawn Team will also be erased.
- 2.1.4. If a Team is withdrawn after the point of the Regular Season at which all Teams have played each other an equal number of times, a 'BYE' will be inserted to replace the withdrawn Team in the fixture, and;
 - a. Competition Fixtures involving the withdrawn Team will be erased including all championship points along with goals scored (for & against).
 - b. All Best & Fairest or Gold Medal votes gained in:
 - (i) Competition Fixtures involving the withdrawn Team up to the point of the season at which all Teams have played each other an equal number of times will be erased;
 - (ii) Competition Fixtures involving the withdrawn Team from the point of the season at which all Teams have played each other an equal number of times, until the time the Team withdrew, will be erased.

For the avoidance of doubt, FV may consider forfeited matches as Played for the purposes of Rule 2.1.4.
- 2.1.5. If the withdrawing team causes the fixture to be imbalanced where all teams do not have the same amount of games played during the season, FV at its discretion will either:
 - a. schedule additional Competition Fixtures during their Regular Season; or
 - b. remove Competition Fixtures from their Regular Season.

If FV decides to proceed in accordance with Rule 2.1.5 (a), Competition Fixtures may be scheduled either mid-week or during a catch up round, at FV's discretion.
- 2.1.6. If a Team withdraws prior to the start of the Regular Season and is not replaced, a "BYE" will be inserted into the fixture or the fixture may be amended to accommodate the new number of Teams where practicable.
- 2.1.7. If a Team withdraws from a league involving fewer than 9 Teams or greater than 10 Teams, additional Competition Fixtures may be added or removed to ensure all Teams play an equal number of Competition Fixtures during the Regular Season.
- 2.1.8. FV may alter the Regular Season Competition Fixture kick-off dates, venues and/or times as it deems necessary in its absolute discretion.

2. COMPETITION RULES

2.2. Player Eligibility

- 2.2.1. A player is eligible to play in his or her Team provided:
- a. the player has been registered in line with FA and FV Registration Regulations;
 - b. all registration fees for the player have been received by FV, subject to Rule 2.2.5.
 - c. the player is not under suspension by FV, FA or FIFA ;
 - d. the player meets the competition's age group and gender rules where applicable and subject to any dispensation granted by FV (refer to relevant FV Regulations);
 - e. the player complies with the Match Record requirements set out in Rule 3.3.
 - f. the player presents a current Player ID Card upon request to the Match Official for the player in the Competition Fixture, where that competition requires ID cards;
 - g. the player meets competition requirements for Finals or Play Off Matches.
- 2.2.2. Any Team which fields an ineligible player may be subject to penalty under the GDT.
- 2.2.3. Any Player playing under a dispensation granted by FV must produce the letter of dispensation on match day upon request by the Match Official. Failing to produce a letter of dispensation upon request by the Match Official may result in a charge of Misconduct under the GDT.
- 2.2.4. The dispensation process and regulations are clearly defined in Football Victoria's [Dispensation Policy](#). FV at its absolute discretion may amend any part of the dispensation policy as required from time to time.
- 2.2.5. At FV's discretion, Clubs/players may be given dispensation from Rule 2.2.1.b. for Cup Fixtures which take place prior to the commencement of the Regular Season.
- 2.2.6. If there is a dispute about a player(s) eligibility on the day of a Competition Fixture, the Match Official must note the details of that dispute and send those details to FV together with an incident report. No Club or Match Official may prevent a player from taking the field in a Competition Fixture on suspicion of ineligibility, unless that player is unable to present an ID Card in accordance with Rule 2.2.1.f.
- 2.2.7. Any decision made by FV regarding rule 2.2 is not subject to appeal.

Gender Rules

- 2.2.8. The Gender Rules form part of the [FV Dispensation Policy](#). FV at its absolute discretion may amend any part of the dispensation policy as required from time to time.
- 2.2.9. Under the Victorian Equal Opportunity Act, it is permitted to treat people differently on the grounds of sex or gender identity in terms of competitive sporting activities from the age of 12 years and over.
- 2.2.10. Football Victoria allows players to play in gendered competition of their choosing under the following guidelines:
- a. Players who identify as non-binary, transgender or intersex are permitted to participate in the competition of their choice, up to the age of U12 for a girl's competition, and up to the age of U13 for a boy's competition.

2. COMPETITION RULES

- b. Players who identify as male are permitted to play in female competitions in accordance with the Equal Opportunity Act 2010 up until Under 12 girls. The player must turn 12 or below during the 2023 calendar year and may play in their equivalent age group of female competitions without the prior approval of FV.
- c. Players who identify as female are permitted to participate in male competitions up until Under 13 boys. The player must turn 13 or below during the 2023 calendar year and may play in their equivalent age group of male competitions without the prior approval of FV.
- d. Players who identify as female are not permitted to participate in male competitions from Under 14 and above with the exception of the player falling into one of the below categories.
 - (i) the player is currently registered to a regional club without any reasonable female pathway available to the player. To be clear a regional club is classified as a Club that has received prior written approval by FV to participate in FV metropolitan community competitions excluding Geelong based clubs; or
 - (ii) the player receives prior written approval from the FA Technical Department.

The Club must provide FV with the following documentation in support of their application for gender dispensation in relation to a regional player and/or an FA-approved player;

- a signed letter from the player's Club president supporting the application.
 - a signed letter from the player's Club Technical Director supporting the application.
 - a signed letter of consent from the players parent (s) or guardian supporting the application.
 - a document listing general medical details of the player by a medical professional including height and weight; and
 - any further information requested.
- e. Players who have affirmed their gender identity by transitioning to a gender that is different to their sex assigned at birth; are in the act of transitioning via gender affirming practices; or are non-binary people, are eligible to nominate to play in a competition of their choosing conducted for their affirmed gender and not sex assigned at birth, unless it gives cause to a risk to themselves or others.

Note: FV may request supporting documentation as part of any application under these guidelines and applicants may be referred to FA's policy.

3. FIXTURE REQUIREMENTS

3. FIXTURE REQUIREMENTS

3.1. Facilities / Pitch Arrangements

3.1.1. It is the responsibility of all Clubs to:

- a. provide a venue that complies with the minimum facility requirements for FV Competitions as prescribed and promulgated by FV from time to time. The minimum class of facility required for relevant FV Competitions is:

- (i) VPLW, Men's & Women's State League, Men's Metropolitan League & Men's Metropolitan Masters - Senior class; and
- (ii) Junior League (U12-U21) – Junior class

Current details of applicable facilities standards for each Division and League are set out in Schedule 6.

- b. provide a safe environment for players, Match Officials, Club Officials and spectators.
- c. ensure that their facilities and equipment are clean and fit for purpose.
- d. ensure that all applicable State and local government statutory and other requirements have been met in respect of their facilities including but not limited to:
 - (i) legitimate approved use of the facility by the owner or land manager.
 - (ii) requirements under the *Planning and Environment Act 1987*, the *Food Act 1984* and the *Building Act 1993* and *Public Health and Wellbeing Act 2008* (including but not limited to any directions issued by the Chief Health Officer);
 - (iii) any local laws including gaming and liquor licence legislation; and
 - (iv) holding an up to date liquor licence (RSA) and/or food handling certificate if applicable.

3.1.2. A Club which advises FV prior to commencement of a Regular Season that it cannot provide facilities in accordance with Rule 3.1 or which, during the course of the season, has facilities which are found by FV to not comply with these requirements may:

- a. have its home fixtures moved to an alternate venue or forfeit those home fixtures if a move to an alternate venue is not possible in FV's opinion.
- b. be required by FV to advise what steps the Club will take to ensure that it can meet its facility requirements and may be relegated to such Division as FV deems appropriate.
- c. have Team(s) withdrawn from competition during the current Regular Season.

3.1.3. At the absolute discretion of FV, a Club which fails to meet its facility requirements under Rule 3.1 may be relegated to a lower Division in the following Regular Season.

3.1.4. FV may in its absolute discretion upon written request with supporting evidence grant a temporary dispensation from compliance with Rule 3.1 to a Club which:

- a. is in the process of upgrading its facilities to meet FV's requirements; or

3. FIXTURE REQUIREMENTS

- b. due to circumstances beyond its reasonable control the Club cannot comply with FV's requirements; or
 - c. has satisfied FV that the Club is taking all reasonable steps to ensure compliance with FV's facility requirements.
- 3.1.5. FV will not grant dispensation under Rule 3.1 from compliance with any requirement that relates to matters of safety or legislative compliance.

3.2. The Technical Area

- 3.2.1. A maximum of nine (9) persons are permitted to be within the Technical Area at any given time during a Competition Fixture. Those persons may only include the coach and assistant coach, the Team manager, the substitutes and a registered health practitioner, sports trainer or accredited first aider.
- 3.2.2. Subject to Rule 3.2.4 all persons must remain seated within the confines of the Technical Area, except in special circumstances e.g., a physiotherapist or doctor entering the field of play, with the Match Official's permission, to assess an injured player.
- 3.2.3. Players may leave the Technical Area to warm up, provided they do not interrupt the view or movement of any Match Official.
- 3.2.4. Only one (1) person may stand up at one (1) time within the Technical Area. It is the Home Club's responsibility to provide sufficient seating for both Clubs in the respective technical areas.
- 3.2.5. All persons within the Technical Area must be wearing colours that clearly distinguish them from all players and Match Officials on the field of play e.g., bibs, jackets.
- 3.2.6. The Match Official may expel any person from the Technical Area at any time as he or she sees fit. The Competition Fixture will not recommence until that person has left the Technical Area and Field of Play to the Match Official's satisfaction.
- 3.2.7. A player or Club Associate who is under suspension must not be present in the Technical Area. Should a player or Club Associate be in breach of this rule they will be subject to further penalties under the GDT.

3.3. Match Records

- 3.3.1. Clubs will adhere to any requirements relating to the use of online match records, results reporting and match data recording, as prescribed by FV from time to time.
 - a. All VPLW, Men's and Women's State Leagues, Men's Metropolitan and Masters are to adhere to the Online Match Record process.
 - b. All Juniors (Under 12 – Under 21) are to adhere to the Match Record book process.
- 3.3.2. Clubs must list on the Match Record all players taking part in a Competition Fixture and must produce a Match Record to the Match Official not less than:
 - a. in the case of senior match fixtures (VPLW, Men's State League & Womens State League), 60 minutes before the commencement of any FV Competition Fixture; or
 - b. all other FV fixtures, 30 minutes prior to the commencement of the fixture.
- 3.3.3. If a Club disagrees with any of the details on a Match Record prior to the commencement of the fixture, the fixture must still take place as per the fixtured start time and refer to Rule 3.3.5.

3. FIXTURE REQUIREMENTS

- 3.3.4. A Match Official has the absolute discretion to amend a Match Record up until 30 minutes after the conclusion of the Competition Fixture. The Match Official must inform a representative of both teams who must sign the Match Record to confirm the amendment.
- 3.3.5. Subject to Rule 3.3.8, a Club may be charged with Misconduct if:
- a. any player listed on the Match Record is ineligible in accordance with either these Rules or the GDT; or
 - b. more than 17 players are listed on the Match Record; or
 - c. it fails to list on the Match Record the shirt number, full name and FA ID number for each player, or adds players to the Match Record after submission to the Match Official without amending the Match Record in accordance with Rule 3.3.4, shall be processed in accordance with the terms of the GDT
- 3.3.6. A representative from each Team must sign the Match Record at the conclusion of the Competition Fixture and should do so only after the appointed Match Official has recorded all outstanding details.
- 3.3.7. If a Club disagrees with any of the details on a Match Record (either its own or the opposition's), the Club must sign and indicate any disputed information by circling the detail in question and submit via the [Match Investigation Form](#) on the FV website.
- Only the following information can be disputed:
- a. Goal Scorers;
 - b. Red and Yellow Cards;
 - c. Final score; or
 - d. Player eligibility.
- 3.3.8. Match Record Disputes will only be investigated by FV in the following circumstances:
- a. the Match Record and a request to conduct a match investigation is lodged with FV within 7 days of the Competition Fixture; and
 - b. the following evidence is submitted by the Club in support of its request for a match investigation:
 - (i) full Match Record;
 - (ii) video and/or photographic evidence;
 - (iii) statutory Declaration(s); and
 - (iv) any other information accepted from the Club at the discretion of FV.
- 3.3.9. FV may extend or abridge the deadline referred to in Rule 3.3.8. at its discretion.
- 3.3.10. Match Records will only be amended if FV is satisfied that the information disputed is proven beyond reasonable doubt.
- 3.3.11. FV reserves the right to amend the Match Records and will only be amended if FV is satisfied that there was no malice or intent to gain an advantage. In this instance, Clubs may not be charged with Misconduct as per Rule 3.3.5.

3. FIXTURE REQUIREMENTS

- 3.3.12. For all fixtures that use match record books, once signed by all parties at the conclusion of the Competition Fixture, each Club must make a copy of its Match Record available to the opposing Team.
- 3.3.13. For fixtures that use online match records (VPLW, WSL & MSL), Clubs must take visible photos of both team sheets post-match once all information has been verified.
- 3.3.14. In the event there is a discrepancy between the team sheet and the team listed on GameDay, the team sheet will prevail.

3.4. Ground Marshals

- 3.4.1. Each Club must provide the number of marshals (Ground Marshals) directed by FV.
- 3.4.2. Ground Marshals must:
 - a. be at least 18 years old and provide the Match Official with their name;
 - b. be in a clearly identifiable uniform;
 - c. be visible from the Field of Play at all times;
 - d. escort the Match Official(s) to and from the change rooms and the Field of Play at the commencement of the Competition Fixture, at half time and at full time; and
 - e. where required, assist the Match Officials(s) to ensure a safe playing environment for all players, Club Officials and spectators.
- 3.4.3. Match Officials must not leave their dressing rooms to enter the Field of Play or return to their rooms from the Field of Play until the identifiable Ground Marshals are present.

- 3.4.4. FV may vary the minimum Ground Marshal requirements for any Competition Fixture at any time.
- 3.4.5. Ground Marshal numbers may be varied in line with FV's Risk Assessment and Security Policy
- 3.4.6. Each home and away Club is required to provide 50% of the required Ground Marshals for each Competition Fixture, failure to do so may result in Misconduct under the GDT.

3. FIXTURE REQUIREMENTS

- 3.4.7. Clubs must ensure the [FV Ground Marshal Handbook](#) is provided to relevant persons prior to completing the duty.

3.5. Player's Strip / Apparel

3.5.1. Clothing

- a. All Teams must nominate a 'Home' and 'Alternate' playing strip. The Club's 'Home' and 'Alternate' playing strips must be entered into FV's online competition management system (GameDay) or provided to FV if requested at least 10 days prior to Round 1 of the Regular Season or the Club in question may incur a penalty under the GDT.
- b. All playing strips must be approved by FV.
- c. Any change to playing strips during the season must be updated on GameDay and communicated to FV 5 working days prior to the Club's next Competition Fixture
- d. Predominantly black playing shirts will not be permitted under any circumstances.
- e. The Home Club in each Competition Fixture is required to wear their nominated 'Home' playing strip.
- f. In the instance of a playing strip clash between the home and away Team as determined by the Match Official, the away Team is required to provide a sufficiently alternate playing strip.
- g. In the instance of a playing strip not being available to a club, it will be deemed the responsibility of the club to ascertain written consent from the opposing club to avoid any playing strip clash. This written agreement must be sent to FV prior to the fixture.
- h. The purpose of Rule 3.5 is to ensure that the two Clubs wear playing strips that distinguish them from each other and also the Match Officials. Clubs and Match Officials should refer to the following table to determine whether or not a strip clash exists. The table lists which items of the strip are permitted to clash for different Divisions/Leagues:

- i. All playing shirts must have a visible number on the back of the shirt.
- j. All playing numbers displayed on shirts must be unique within the Team.

3. FIXTURE REQUIREMENTS

- k. A Club may be penalised in accordance with Rule 4.6 if:
 - (i) a Competition Fixture does not commence due to an inability to resolve a clash of strips, and it can be established that such Club or Team did not comply with Rule 3.5.1, or
 - (ii) a Club changes their home playing strip without notifying FV Competitions via competitions@footballvictoria.com.au by no later than five days (5) prior to Competition Fixture, and this change results in a Competition Fixture being postponed as a result of a strip clash.
- l. Goalkeepers may wear any colour provided their strip does not clash with either Team or the Match Official.
- m. All Clubs must have two (2) goalkeeper strips available at all home and away fixtures.

3.5.2. *Protective Gear*

- a. Any player requiring vision correction should wear contact lenses, or wear spectacles that:
 - (i) are firmly secured with a sports band or adjustable strap.
 - (ii) have purpose-designed and closely fitted curled ends on the arms; or
 - (iii) are specially designed protective sports glasses constructed of plastic with rubberised cushioning and no metallic parts.

3.5.3. Players Equipment must be in line with IFAB Laws of the Game.

3.6. **Stretchers / First Aid**

- 3.6.1. Each Home Club must allocate one (1) stretcher suitable for first aid and emergency use for each pitch hosting a Competition Fixture.
- 3.6.2. Each Home Club must provide a First Aid Kit including, but not limited to:
 - a. Band Aids;
 - b. Bandages; and
 - c. Ice Pack (or other available ice).
 - d. Must provide a hospital register clearly visible in the first aid and match officials room.

3.7. **Smoking / Drinking at Venues**

- 3.7.1. It is prohibited for anyone to smoke or consume alcohol within the confines of the Field of Play.
- 3.7.2. Clubs are responsible for ensuring that smoking and drinking alcohol are confined to licensed and permitted areas. Clubs should be familiar with and refer to State legislation regarding current smoking laws.

3.8. **National Flags, Slogans & Emblems**

- 3.8.1. Clubs must comply at all times with the [FA Diversity & Inclusion Policy](#)

3. FIXTURE REQUIREMENTS

- 3.8.2. All Clubs must have the prior written approval of FV before introducing or incorporating any design, emblem or slogan onto any Club logo or name, product or medium, including but not limited to playing strips, promotional material, Club letterhead, banners, advertisements, public announcements, website or any other form of communication.
- 3.8.3. FV may require the immediate removal of any offending material at any time.

3.9. Lighting Standards

- 3.9.1. Clubs wishing to play Competition Fixtures under lights must ensure that lighting for those Competition Fixtures complies with FV's Football Lighting Policy referred to as Rule 9.



4. FIXTURE DETAILS

4. FIXTURE DETAILS

4.1. Duration of Competition Fixtures

4.1.1. Periods of Play

- a. All Competition Fixtures will be played over Normal Time as specified in Table 4.1.

- b. Periods of play for specific competitions may be altered by FV provided they are implemented throughout the age group or competition.
- c. Prior to the commencement of the Competition Fixture, the Match Official may reduce the length of each half if in the Match Official's opinion playing conditions compromise player safety or to prevent the delay to the commencement of any subsequent Competition Fixture from its scheduled kick off time only if:

4. FIXTURE DETAILS

- (i) it is in line with IFAB rules; and
- (ii) he or she has notified the Coach/Team Manager of each participating Team.

4.1.2. *Commencement Time*

- a. Teams must be ready to begin playing by the stated kick off time.
- b. If either Team is not ready to begin playing within 15 minutes of the scheduled kick off time the Match Official may determine the Competition Fixture as Abandoned in accordance with Rule 4.2.
- c. In circumstances where both Teams and the Match Official agree, the Competition Fixture may commence up to 30 minutes after the scheduled kick off time, provided it does not delay the kick off of subsequent Competition Fixtures either at that venue or to which the Match Official is also appointed on that day.

4.1.3. *Half Time Interval*

- a. The half-time interval must be a minimum of 5 minutes and no longer than 15 minutes in duration for all competitions except for the Under 12 & Under 13 competitions.
- b. The half-time interval must be a minimum of 5 minutes and no longer than 10 minutes in duration for the Under 12 & Under 13 competitions.

4.2. **Abandoned Competition Fixtures**

4.2.1. Competition Fixtures may only be abandoned by a decision of the Match Official or FV.

4.2.2. The Competition Fixture may be abandoned for any, but not limited to, one of the following reasons:

- a. if either Team has its playing numbers reduced for any reason below the minimum IFAB requirement of seven (7) players;
- b. if the lighting at the venue fails such that in the opinion of the Match Official it is impossible or unsafe to continue to play;
- c. if the Match Official or FV determines that playing conditions have become unsafe or untenable for any reason;
- d. if the Match Official, in consultation with security staff and ground marshals where applicable, determines that the conditions for players, coaches, Match Officials or supporters have become unsafe or untenable for any reason;
- e. if one or both of the Teams is not ready to commence the Competition Fixture within 15 minutes of the scheduled kick-off time; or
- f. in accordance with Rule 4.4, and Clubs must use reasonable endeavours to report any likely abandonment circumstances to FV in advance, particularly in order to avoid unnecessary travel by regionally based Club and Teams.

4.2.3. If a Competition Fixture is abandoned due to a matter set out in Rule 4.2.2, FV may determine one of the following outcomes of the Competition Fixture at its absolute discretion:

4. FIXTURE DETAILS

- a. If 80 per cent or more of the Normal Time of a Competition Fixture has been played then the score at the time of abandonment may stand. 'Played' in the context of this Rule will be determined by FV in consultation with the Match Official.
 - b. If a competition fixture has been abandoned after between 60% and 80% of the Normal Time of a Competition Fixture has been played and the goal difference between the two teams exceeds 4 or more goals, FV may determine that the result be maintained at the time of abandonment. E.g. 4-0, 5-1, 6-2.
 - c. Competition Fixture to be replayed in full.
 - d. Competition Fixture to be awarded as a 'No Result'.
 - e. Competition Fixture result is 0-0.
 - f. Competition Fixture result is 3-0 to the non-offending Team, unless the goal difference at the time of abandonment was greater and in favour of the non-offending Team, in which case the greater result will stand. In determining what is a 'greater' result, FV will give preference to goals FOR in the first instance (i.e. 4-1 will be considered a 'greater' result than 3-0).
 - g. Competition Fixture to be replayed from the time at which the original Competition Fixture was abandoned. In the event a Competition Fixture is replayed in accordance with this Rule:
 - (i) The score at the time of the abandonment remains the score at the time the Competition Fixture recommences; and
 - (ii) Only players listed on the Match Record for the initial Competition Fixture between the two sides will be eligible to compete in the recommenced Competition Fixture, unless FV determines that additional players are eligible (for example, in the case of player injury with supporting medical documentation); and
 - (iii) FV will determine what, if any, further substitutions are allowed by each Team during the recommenced Competition Fixture, giving consideration to the number of substitutions made in the Competition Fixture before it was originally abandoned (including which players may take the Field of Play or be substituted on).
 - (iv) FV will determine at its absolute discretion the date time and venue for the recommenced fixture.
 - (v) Player, coach or team unavailability resulting in team non-participation in the recommenced fixture will result in a 3-0 forfeit to the offending team.
 - h. Competition Fixture result at time of abandonment shall stand.
- 4.2.4. Any Club or Club Associate found to be responsible either in whole or in part for the abandonment of a Competition Fixture may be subject to penalties under the GDT.
- 4.2.5. When a Competition Fixture is abandoned:
- a. after commencement of the Competition Fixture, all Match Officials are entitled to receive 100% of their normal match fee; or
 - b. prior to commencement of the Competition Fixture, all Match Officials are entitled to receive 50% of their normal match fee if the Match Official(s) were present at the venue when the Competition Fixture was due to commence.

4. FIXTURE DETAILS

- 4.2.6. Match Officials may not claim more than one (1) postponed match fee from one venue on one day.
- 4.2.7. If a Competition Fixture is abandoned by the Match Official, both the Match Official and the Home Club must notify FV by close of business on the next working day that the Competition Fixture has been abandoned.

4.3. Postponed/Rescheduled Competition Fixtures

- 4.3.1. Competition Fixtures may be cancelled, postponed, replayed, or rescheduled by FV in its absolute discretion. Otherwise Competition Fixtures may only be postponed or rescheduled by appointed Match Officials or FV competitions staff.
- 4.3.2. FV may reschedule Competition Fixtures at its absolute discretion. In exercising that discretion, FV:
 - a. is not subject to the deadlines or timeframes whether set out in these Rules or otherwise; and
 - b. will take into consideration all relevant circumstances including but not limited to league standings and the scheduling of Cup Fixtures.
 - c. will not compensate any clubs due to the cancellation, postponement or rescheduling of Competition Fixtures.
- 4.3.3. FV will determine the new time and date for the playing of a postponed/rescheduled Competition Fixture. Clubs are obliged to fulfill any postponed or rescheduled Competition Fixture as determined by FV and any Club which fails to do so will automatically forfeit the Competition Fixture and may be subject to penalty under the GDT.
- 4.3.4. Any postponed or abandoned Competition Fixture that requires rescheduling will be rescheduled to the next available catch-up round or midweek at FV's discretion.
- 4.3.5. Any Competition Fixture scheduled by FV to be replayed must be completed by no later than one (1) week after the conclusion of the Regular Season unless otherwise approved or directed by FV in writing. FV may record the result of any Competition Fixture not completed within this time frame as a 'No Result'.
- 4.3.6. Any Club Associate or Club found guilty of rearranging a Competition Fixture or requesting the appointment of Match Officials outside a set kick-off time or date will be subject to Misconduct charges under the GDT. FV may also record the final score of any such Competition Fixture as a 'No Result'.
- 4.3.7. In the event of a postponed or abandoned Competition Fixture which is required to be replayed, Clubs may, within five (5) business days from the originally scheduled Competition Fixture, arrange an alternate date and venue. The date must fall within the Regular Season. Both date and venue must be approved by FV. If no venue and date is approved by FV, the Competition Fixture will be rescheduled at FV's absolute discretion.
- 4.3.8. With the exception of where the COVID 19 Rules – Impacted Community Competitions apply, any other Player, coach, or team unavailability resulting in team non-participation in the rescheduled fixture will result in a 3-0 forfeit to the offending team.

4. FIXTURE DETAILS

4.4. Weather Conditions

- 4.4.1. FV and/or the Match Official may postpone, delay or abandon any Competition Fixture due to weather and/or pitch conditions such as but not limited to excessive heat/humidity, lightning or rain that may endanger participants' health and/or safety.
- 4.4.2. Refer to the [FV Extreme Weather Policy](#) for all rules and guidelines regarding extreme weather conditions.

4.5. Match Points

- 4.5.1. In all Competition Fixtures, match points will be awarded as follows:

Result	Match Points Awarded
WIN	Three (3) points
DRAW	One (1) point
LOSS	Zero (0) points
FORFEIT	Three-nil loss
NO RESULT	Zero (0) points and zero (0) goals awarded to either team

- 4.5.2. FV reserves the right to record any Competition Fixture as a 'No Result' if the circumstances require or as a result of a breach of these Rules.
- 4.5.3. At the end of the Regular Season, all Teams will be ranked from highest to lowest by virtue of the total number of match points received.
- 4.5.4. If more than one (1) Team finishes the Regular Season on the same number of points, their final position will be determined as follows:
 - a. The Team with the greatest Goal Difference will finish higher.
 - b. If Goal Difference is the same, then the Team that has scored the most goals FOR will be deemed to have finished higher.
 - c. If Goal Difference is the same and goals FOR is the same, then the final order will be determined by the aggregate results of Competition Fixtures played between those Teams for the current season (excluding Cup Fixtures).
 - d. if the aggregate scores between the Teams are the same, then AWAY goals will count as double.
- 4.5.5. If more than one (1) Team has the identical number of Rule 4.5.4 then those Teams will be deemed to have tied.
- 4.5.6. If the final standing in any League is affected by a tie in accordance with Rule 4.5.5 so that it has a bearing on promotion or relegation to another League, Finals or Playoffs, then FV may fixture a Play Off Match between the tied Teams in accordance with these Rules to separate them.

4. FIXTURE DETAILS

4.6. Non- Participation in a Competition Fixture (unless not permitted to do so as a direct result of Protocols issued by the Australian Government or Victorian Government)

- 4.6.1. If both Clubs/Teams refuse to play or are not ready to commence the Competition Fixture as scheduled (refer to Rule 4.2.2.e), FV may award a 'No Result'.
- 4.6.2. Where a Team forfeits a Competition Fixture, the forfeiting Team shall be fined as follows, where notification of the forfeit is:
 - a. before 9:00am, 2 days prior to the Match, no Fine shall apply;
 - b. after 9:00am, 2 days prior to the Match, a Fine of \$150 will be enforced.
 - (i) the Day of Play does not count towards the total days prior, for example, if notification of a Forfeit is received after 9:00am Friday for a Competition Fixture on Sunday, a \$150 will be enforced.
- 4.6.3. Forfeit Fines are applicable for the following community competitions:
 - a. Victorian Premier League Womens
 - b. Men's State League
 - c. Women's State League
 - d. Men's Metropolitan & Masters
 - e. Metropolitan Juniors
- 4.6.4. For avoidance of doubt late forfeit fines are not applicable for MiniRoos (Under 7 – Under 11) competitions.
- 4.6.5. Non-participation and forfeit fines for specific competitions may be altered by FV provided that they are implemented throughout the competition.
- 4.6.6. When insufficient players are available for a Competition Fixture, a senior Team within a Club must take priority over a reserve Team. Failure to field a senior team may result in a 3 – 0 forfeit for both the seniors and reserves fixtures.
- 4.6.7. If a Club's reserves Team fails to participate in four (4) Competition Fixtures, FV may, at its absolute discretion, remove the Club's senior Team from its League during the Regular Season.
- 4.6.8. Forfeits may also constitute a Misconduct under the GDT and be dealt with as such.

4.7. Change of Venue/Fixture Requests by Club

- 4.7.1. *Change of Venue Requests*
 - a. Change of venue requests may only be made on the basis of perceived unplayable pitch or venue conditions, or to relocate a Competition Fixture to an improved facility.
 - b. A written request, including booking confirmation, to relocate a Competition Fixture to an improved facility must be received by FV no less than 14 days prior to the scheduled Competition Fixture. FV shall consider factors such as maintaining kick off times, relative distance to travel and the quality of the facility and playing surface

4. FIXTURE DETAILS

when considering such requests. Any request that involves a change to kick-off times or dates will be subject to Rule 4.7.2.

- c. Any change request based on deteriorating pitch or venue conditions may be considered with supporting evidence provided within the 14-day period prior to the Competition Fixture at the absolute discretion of FV.

4.7.2. *Fixture Date/Time Change Requests*

- a. FV will consider a fixture change request by a Club if the request is received no less than 14 days prior to the fixture with written consent provided to FV by Club Officials of both Clubs. Exemptions may be granted for Rounds 1-3 (and 4-5 for Leagues which have been subject to regrading).
- b. No date or time change request will be accepted for the final round of any Men's or Women's VPLW or State League fixture.
- c. Scheduled FV competition catch-up and Cup Fixture rounds will only be used in the case of postponed or abandoned Competition Fixtures.
- d. Exemption from Rule 4.7.2.c may only be made if;
 - (i) a request is made in accordance with Rule 4.7.2.a; and
 - (ii) five (5) days prior to the catch-up or Cup Fixture round neither Club is involved in any other Competition Fixture being played in that catch-up or Cup Fixture round.

4.7.3. Rules 4.7.1 and 4.7.2 do not apply to Finals or Play Off Matches.

4.7.4. Any decision to reschedule a Competition Fixture (or otherwise) under Rule 4.7 is subject to FV's right to reschedule a Competition Fixture in accordance with Rule 4.3.2.

4.7.5. FV decisions in relation to rescheduling of Competition Fixtures are final and binding on all parties and are not subject to appeal.

4.7.6. FV holds ultimate power and absolute discretion over the fixturing of Competition Fixtures.



5. MATCH OFFICIALS

5. MATCH OFFICIALS

5.1. Match Official Fees

- 5.1.1. FV will endeavour to appoint a Match Official to each Competition Fixture, subject to availability and applicable fixture schedule.
- 5.1.2. [2023 Match Official Fees](#) are set out on the FV website and will apply for the duration of the Regular Season, although will be subject to change at any time.
- 5.1.3. Unless otherwise stated in the Competition Regulations, payment in cash or cheque of all Match Official fees must be made by the Home Club on the day of the Competition Fixture.
- 5.1.4. If payment is made by cheque, and that cheque is subsequently dishonoured, the Club will be invoiced for the outstanding amount plus any costs reasonably incurred by FV as a result of the cheque being dishonoured.
- 5.1.5. If a Competition Fixture is abandoned or postponed, all Match Officials are entitled to receive match fees in accordance with Rule 4.2.5.

5.2. Assistant Match Officials

- 5.2.1. Where available, two (2) assistant Match Officials shall be appointed to a Competition Fixture to assist the Match Official.
- 5.2.2. If insufficient assistant Match Officials have been appointed, each Team must provide an assistant Match Official. Failure to comply will result in a forfeit by the Team which fails to provide an assistant.
- 5.2.3. No Player (s) listed on a Match Record or Team Sheet can act as a Match Official for that Competition Fixture.

5.3. Non – Attendance or Unavailability of Match Officials

- 5.3.1. If the Match Official fails to honour their appointment, the next most senior Match Official (**Replacement**) will take charge of the Competition Fixture.
- 5.3.2. If the Match Official is late arriving at a Competition Fixture, the Replacement will take charge until the Match Official is ready to take over.
- 5.3.3. If no registered Match Official is present to act as the Replacement ten (10) minutes prior to scheduled start of the Competition Fixture, both Clubs shall agree on a person to act as the Match Official for the Competition Fixture, or until the appointed Match Official arrives. If, by the scheduled kick off time, no agreement can be reached, the Home Club must appoint a person to act as the Match Official for the Competition Fixture. If the match is not played due to the away team disputing the match official appointment, the away team may be deemed to have caused the abandonment of the competition fixture.
- 5.3.4. If a Competition Fixture does not kick off within 15 minutes of the scheduled kick off time due to the absence of a Match Official, the Home Club may be deemed to have forfeited the Competition Fixture.
- 5.3.5. All Clubs must fulfil all Competition Fixtures, regardless of whether or not the FV appointed Match Official is present to take charge. Failure to do so may result in a penalty under the GDT.

5. MATCH OFFICIALS

- 5.3.6. No Player (s) listed on a Match Record or Team Sheet can act as a Match Official for that Competition Fixture.

5.4. Decisions of the Match Official

- 5.4.1. The decisions of the Match Official(s) about any fact connected with play are final and cannot be disputed by any party.

5.5. Pitch and Facility Inspection Report

- 5.5.1. At the conclusion of each Competition Fixture, the Match Official must complete a Pitch & Facility Inspection Report where necessary, and then ensure all relevant Competition Fixture documentation is lodged with FV within two (2) days.

5.6. Match Records and Misconduct Reports (Match Officials)

- 5.6.1. At the conclusion of each Competition Fixture, the Match Official shall consult with his or her assistant Match Officials, where appointed, and confirm the accuracy of all Competition Fixture information before completing each Team's Match Record.
- 5.6.2. Match Records must be submitted via the [Online Post Match Submission Form](#) or via GameDay Online Match Record process for relevant leagues (VPLW, WSL, MSL) and:
 - a. submitted by the Match Official to FV in relation to all Men's and Women's VPLW and State League Competition Fixtures (seniors and reserves); and
 - b. retained by all Match Officials and Clubs in relation to each Competition Fixture for a minimum of 12 months from the end of the Regular Season in which the Competition Fixture took place, and a copy submitted to FV if requested.
- 5.6.3. Match Records required to be submitted to FV in accordance with Rule 5.6.2 must be submitted within 48 hours of the completion of the relevant Competition Fixture for fixtures that use match record books and within 24 hours of the completion of the relevant Competition Fixture for Men's and Womens VPLW and State League Competition Fixtures (in accordance with Rule 5.6.2.a) or a request from FV (in accordance with Rule 5.6.2.b).
- 5.6.4. Misconduct Reports must be submitted in accordance with the requirements set out in the GDT and Rule 5.6.3.

5.7. Player Safety and Blood Rule

- 5.7.1. The Match Official must ensure that any player who suffers an injury or wound which results in the loss of blood leaves the pitch immediately for the purpose of receiving medical attention and for the safety of other players.
- 5.7.2. The Match Official may allow the injured player to re-join the Competition Fixture only after the Match Official is satisfied that the injury or wound has been safely covered and contained.
- 5.7.3. If a player's uniform or attire has blood on it, the Match Official may require the player to change his or her attire before re-joining the Competition Fixture.
- 5.7.4. If the injured player is required to change his or her uniform, and a shirt displaying the same number as the original shirt is unavailable, the Match Official may allow the player to wear an alternative numbered, or blank, playing shirt.

5. MATCH OFFICIALS

5.8. Match Reporting

- 5.8.1. Match Officials must enter all match results & player data in accordance with Rule 11.4.
- 5.8.2. Match Officials will be required to adhere to any requirements relating to the use of online match records, results reporting and match data recording, as prescribed by FV from time to time.

10. COMPETITION STRUCTURE

10.1. General Information

- 10.1.1. These Regulations shall apply to all Men’s State League senior and reserve grade fixtures within the following metropolitan FV competitions.

- 10.1.2. Number of teams is determined by FV in its absolute discretion.
- a. FV will determine the Men’s State League structures at their absolute discretion.
- 10.1.3. FV reserves the right in its absolute discretion to amend the structure of Community Competitions, including the number of Clubs in each Division, before, during or after the Regular Season, as a result of FA actions, including the establishment of any new or varied FA auspiced Leagues or Divisions, or compulsory Player pathways.
- 10.1.4. Any promotion and relegation provisions referred to in Rule 10 are subject to Community Competitions continuing in 2023 in the same, or substantively the same, structure. For the avoidance of doubt any promotion and relegation of teams is at the absolute discretion of FV. There is no right to promotion.
- 10.1.5. FV reserves the right to determine dates and times of Competition Fixtures with specific regards to the number of matches played within the immediate proximity of the relevant Competition Fixture; including but not limited to Australia Cup and Dockerty Cup commitments.

10. COMPETITION STRUCTURE

- 10.1.6. Subject to these Rules and Regulations at the end of the Regular Season, including any Finals or Play Off Matches, the final standings of each League may determine which Clubs are eligible to be promoted or relegated between Divisions. A Club that earns the right to be promoted shall only be promoted for the following season provided it:
- a. has no outstanding debts to FV;
 - b. has complied with any Rules or Regulations for Clubs participating in the relevant League or Division including but not limited to those relating to facility and pitch requirements by the date prescribed by FV from time to time; and
 - c. is not otherwise in breach of these Rules and Regulations or any other requirements of FV.
- 10.1.7. All senior and reserves Teams will play on the same day with all reserve Competition Fixtures played as a curtain raiser to the senior Competition Fixture on that day, unless otherwise determined by FV.
- 10.1.8. Subject to Rule 10.1.9, no Club may enter more than one (1) Team (including reserves) in Men’s State League competitions.
- 10.1.9. Melbourne University Soccer Club is permitted to field two different Teams in the Men’s State League competitions (under the names Melbourne University Soccer Club and University of Melbourne Soccer Club) provided that:
- a. Those Teams are not permitted to compete in the same League;
 - b. Should one of those Teams cease to participate in Men’s State League competitions (for any reason), that Team will not be permitted to re-enter Men’s State League competitions without first establishing a Club independent of Melbourne University.
 - c. Once a player plays one (1) Competition Fixture for one (1) of the Teams fielded by either Melbourne University Soccer Club or University of Melbourne Soccer Club during a Regular Season, that player will immediately become ineligible to play for the other Team during that Regular Season (including Play Off and Finals matches).
- 10.1.10. To be eligible to participate in senior men’s competitions run by FV, players must be 15 years of age (or older) as at 1 January 2023, unless an application to FV for exemption from Rule 10.1.10 is made by the player’s Club on behalf of a player and is approved by FV.
- 10.1.11. An application made under Rule 10.1.10 must meet the following minimum criteria:
- a. The application must be supported by a signed letter from the player’s Club president supporting the application;
 - b. The application must be supported by a signed letter from the player’s State Team/Representative Team coach or Club Technical Director;
 - c. The application must be supported by a signed letter of consent from the player’s parent or guardian supporting the application;
 - d. The application must be supported by a signed letter of support from the player’s medical professional listing general medical details of the player including height and weight and;
 - e. The Club/player must provide FV with any further information requested.

10. COMPETITION STRUCTURE

- 10.1.12. An application made under Rule 10.1.10 will be considered by the FV. FV has absolute discretion in relation to any application made under that Rule.
- 10.1.13. MSL1 Clubs will only be permitted to list four (4) Visa players however, at least one (1) of these must have a nationality of an AFC Member Association (3+1 AFC Visa Ruling) on their Senior match day team sheet.
- 10.1.14. Any MSL1 Club that lists more than four (4) Visa players (3+1 AFC Visa Ruling) on their Senior team match day team sheet will be in breach of Rule 10.1.13 and may be in breach of Rules regarding fielding an ineligible player(s).
- 10.1.15. It is entirely the Clubs responsibility to ensure players are eligible in relation to the 3+1 AFC Visa ruling.

10.2. Victorian Men’s State Leagues

- 10.2.1. All Clubs participating in Divisions 1 to 5 of the Victorian Men’s State Leagues must field a senior Team and a reserves Team.
- 10.2.2. By the commencement of the 2023 Regular Seasons for the competitions listed in subparagraphs a – h below, all Clubs participating in Divisions 1-3 of the Victorian Men’s State Leagues must field and maintain not less than three (3) additional teams in FV competitions (other than their senior men and reserves Teams). Those Teams can be fielded in any of the following Leagues (or a combination thereof):
 - a. MiniRoos (Under 7s – U11s);
 - b. Juniors (Under 12s – U21s);
 - c. VPLW/ Women’s State Leagues;
 - d. Metropolitan League;
 - e. Metropolitan Masters;
 - f. Womens Football 7s
 - g. FV affiliated regional competitions; or
 - h. FV affiliated All Abilities Leagues.
- 10.2.3. A Club which fails to comply with Rule 10.2.2 may:
 - a. not be eligible for promotion at the end of the 2023 Regular Season; and
 - b. be subject to relegation from its current Division at the discretion of FV.
- 10.2.4. All Men’s State League Teams in all divisions will play each other on a home and away basis over 22 Rounds unless otherwise determined by FV in its absolute discretion.
- 10.2.5. MSL1 Competition Fixtures will be played on Friday, Saturday, Sunday or Monday. FV may schedule MSL1 Competition Fixtures on other days as it deems necessary in the circumstances.
- 10.2.6. MSL2-5 Competition Fixtures will be played on Friday, Saturday or Monday. FV may schedule MSL2-5 Competition Fixtures on other days as it deems necessary in the circumstances.
- 10.2.7. Friday or Monday night Competition Fixtures:

- a. may not kick off earlier than 6.15pm (reserves) or 8.30pm (seniors), unless either Competition Fixture has been rescheduled according to Rule 4.3 or as determined by FV at its absolute discretion; and
 - b. cannot be scheduled if the distance between the home venues of the two (2) Teams exceeds 50km, unless upon written agreement of the two (2) Teams in question or as determined by FV at its absolute discretion.
- 10.2.8. Saturday Competition Fixtures may not kick off earlier than 12.15pm (reserves) or 3.00pm (seniors), unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 10.2.9. Saturday Competition Fixtures may not kick off later than 6.30pm (reserves) or 8.30pm (seniors), unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 10.2.10. The applicable kick off times for Saturday Competition Fixtures apply to any Competition Fixtures held on public holidays.
- 10.2.11. Fixtures may only be played on public holidays with the permission of FV.
- 10.2.12. Subject to this Regulation or unless otherwise determined by FV acting in its discretion, the Team finishing top of each League at the conclusion of the Regular Season may be crowned Premiers and the second placed Team may be Runner-up. For the avoidance of doubt, simply finishing in first or second place on the ladder does not entitle the Team to be named Premiers or Runners Up.
- 10.2.13. All promotion and relegation Regulations outlined below are based on the continuation of the current FV competition structure for Victorian Men’s State Leagues. FV reserves the right to alter any competition structure for the following Regular Season. Any vacancy created as a result of such a restructure may be filled in accordance with these Rules and Regulations.
- 10.2.14. All Victorian Men’s State League Clubs are required to enter and participate in the Australia Cup and upon qualification the Dockerty Cup Semi Finals and Final. Failure to comply may result in a Club facing a penalty or other sanction for Misconduct under the GDT.

10.3. Promotion and Relegation

- 10.3.1. Teams may be relegated from NPL3 to MSL1 in the following season as promulgated by FV from time to time.
- 10.3.2. The Premier and Runner up of each League of MSL1 (NW and SE) may be eligible for promotion from MSL1 to NPL3 in the following season, provided those Clubs meet the requirements outlined in the NPL3 license agreement as promulgated by FV from time to time.
- 10.3.3. To be eligible for promotion into NPL3, Clubs will be required to adhere to the licensing requirements for that level of competition. FV reserves the right to review clubs who cannot meet the criteria. Clubs who breach or cannot meet the criteria may be fined, removed, or not offered a position into that tier of competition.
- 10.3.4. Those Clubs finishing in second last and last position of each League (NW and SE) of MSL1 may be relegated to MSL2 for the following season.
- 10.3.5. The Premier and Runner-up of each League (NW and SE) of MSL2 may be eligible for promotion to MSL1 for the following season.
- 10.3.6. Those Clubs finishing in second last and last position of each League (NW and SE) of MSL2 may be relegated to MSL3 for the following season.
- 10.3.7. The Premier and Runner-up of each League (NW and SE) of MSL3 may be eligible for promotion to MSL2 in the following season.
- 10.3.8. Those Clubs finishing in second last and last position of each League (NW and SE) of MSL3 may be relegated to MSL4 for the following season.
- 10.3.9. Those Clubs finishing in third (3rd) last position of each League (NW and SE) of MSL3 may playoff against the winning Clubs referred to in 10.3.11 and 10.3.12.
- 10.3.10. The Premier of each League (N, W, S and E) of MSL4 may be eligible for promotion to MSL3 in the following season.
- 10.3.11. The Club finishing Runner-up of MSL4 North may playoff against the Club finishing Runner-up in MSL4 West following the conclusion of the regular season at a mutual venue determined by FV.
- 10.3.12. The Club finishing Runner-up of MSL4 South may playoff against the Club finishing Runner-up in MSL4 East following the conclusion of the regular season at a mutual venue determined by FV.
- 10.3.13. The winner of the Play Off referred to in 10.3.11 may advance to playoff against the Club finishing in third (3rd) last position of MSL3 North-West.
- 10.3.14. The winner of the Play Off referred to in 10.3.12 may advance to playoff against the Club finishing in third (3rd) last position of MSL3 South-East.
- 10.3.15. The winner of the Play Offs referred to in 10.3.13 and 10.3.14 may either be eligible to retain their position in MSL3 the following season or eligible to earn promotion into MSL3 the following season.
- 10.3.16. The losing team of the Play Offs referred to in 10.3.13 and 10.3.14 may either be eligible to be relegated to into MSL4 the following season or retain their position in MSL4 the following season.

- 10.3.17. Those Clubs finishing in second last and last position of each League (N, W, S and E) of MSL4 may be relegated to MSL5 for the following season.
- 10.3.18. The Premier and Runner-up of each League of MSL5 (N, W, S and E) may be eligible for promotion to MSL4 for the following season.
- 10.3.19. The Club finishing third (3rd) of MSL5 North may playoff against the Club third (3rd) in MSL5 West following the conclusion of the regular season at a mutual venue determined by FV.
- 10.3.20. The third (3rd) placed Club of MSL5 North shall play against the third (3rd) placed Club of MSL5 West.
- 10.3.21. The third (3rd) placed Club of MSL5 South shall play against the third (3rd) placed Club of MSL5 East.
- 10.3.22. The winners of the Play Offs referred to in Rules 10.3.20 and 10.3.21 may playoff at a mutual venue determined by FV where the winner may be eligible for promotion to MSL4 in the following season.
- 10.3.23. The losing teams of the Play Off referred to in 10.3.20 and 10.3.21 may retain their position in MSL5 the following season.
- 10.3.24. There may be relegation from MSL5 in the event of an increase in Teams necessitating the creation of a Men’s State League 6 Division. Teams relegated to MSL6 will be determined by their previous season’s final standings.
- 10.3.25. In leagues with a ‘bye’ the bye may not be included as a place in relation to the ladder standings.
- 10.3.26. A Club promoted or relegated in accordance with Rule 10.3 will not automatically be promoted or relegated into the corresponding League in the Division above or below. For example, a Club promoted from MSL5E will not automatically be promoted to MSL4E. Decisions regarding League positioning will be made by FV at its absolute discretion and in the best interests of League and Division structures for the following season.
- 10.3.27. The selection of venues for the 2023 MSL Play Off matches will be determined at the absolute discretion of FV
- 10.3.28. Promotion and relegation positions are at the absolute discretion of FV and may be amended at any time prior to the commencement of the competition season, during the competition season or post competition season.
- 10.3.29. FV in its discretion may permit a club to self-relegate from their current MSL Competition for the following season provided it receives notification from the club no later than 28 days after the conclusion of the regular season.
- 10.3.30. FV will cover all Match Official Match Fees for all 2023 MSL1-5 Finals and Play Off matches.

10.4. Vacancies in Victorian Men’s State League

- 10.4.1. From time to time vacancies are created in Men’s State League Division due to:
 - a. Clubs not accepting the opportunity to be promoted;
 - b. a Team withdrawing from a MSL Division or League;

- c. a Team being expelled from a MSL Division or League;
 - d. a Team being deemed ineligible for promotion as a result of a breach of these Rules and/or Regulations;
 - e. a Team being relegated as a result of a breach of these Rules and Regulations; or
 - f. other reasons from time to time.
- 10.4.2. If a vacancy is created in a Men’s State League Division prior to the commencement of the Regular Season (whether that vacancy is created during the previous Regular Season or in the ‘off-season’ prior to the commencement of the Regular Season in question), FV shall have absolute discretion when filling a vacancy. FV may choose to leave the vacancy and replace it with a bye, fill the vacancy as per Rule 10.4.3 or decide upon an alternate outcome in FV’s absolute discretion.
- 10.4.3. Vacancies created in accordance with Rules 10.4.1 and 10.4.2 may be filled in the following order of priority:
 - a. the highest finishing Team which is to be, or has been, relegated in accordance with these Regulations from the Division (refer to Rule 1.1.5.h) in which the vacancy arises;
 - b. if applicable, the highest finishing loser of the Play Off Final matches referred to in Rule 10.3 (if relevant).
 - c. remaining Teams which are to be, or have been, relegated in accordance with these Regulations from the Division in which the vacancy arises in order of merit;
 - d. the highest finishing Team which misses out on promotion in accordance with these Regulations, from the Division below the Division in which the vacancy arises; and
 - e. remaining Teams which miss out on promotion in accordance with these Regulations, from the Division below the Division in which the vacancy arises in order of merit.
- 10.4.4. In deciding on order of merit for the purposes of Rule 10.4.3 or where two Teams are otherwise equal for the purposes of Rule 10.4.3, those Teams will be ranked according to the following (and in this order):
 - a. league finishing position for respective teams;
 - b. average points per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - c. average Goal Difference per game for the current regular season (i.e., the season before the regular season in which the vacancy needs to be filled);
 - d. average goals FOR per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - e. the Team and the Club’s disciplinary record for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled).
- 10.4.5. If Teams cannot be separated under Rule 10.4.4 then those Teams will be required to play a Play Off Match in circumstances where they both seek promotion to the higher Division in question.
- 10.4.6. FV, at its discretion, may decide not to fill a vacancy in Men’s State League competition especially when by doing so would disrupt lower Leagues and Divisions, for example

where a League vacancy is created in close proximity to the start of the relevant Regular Season.

10.5. New Entries and ‘Byes’

- 10.5.1. All Clubs may apply for entry into Men’s State Leagues. FV will determine all applications in its absolute discretion and its decision is not appealable.
- 10.5.2. Any Club entering a new Team into Men’s State Leagues will be automatically placed into the lowest Division available (currently MSL5) unless otherwise determined by FV.
- 10.5.3. In the event a Team withdraws from any League of Men’s State Leagues creating an uneven number of matches per Team throughout that Regular Season, FV may organise and schedule additional Competition Fixtures, alter the current season fixture or remove Competition Fixtures to produce an even number of matches for each Team.

11. FIXTURE REQUIREMENTS

11.1. Substitution

- 11.1.1. A maximum of seventeen (17) players may be listed on the Match Record. Each senior Team may use a maximum of five (5) substitutes with a maximum of three (3) substitution opportunities and may additionally make substitutions at half time during any senior MSL Competition Fixture. No more than six (6) substitutes are permitted to be named on the Match Record.
- 11.1.2. A maximum of seventeen (17) players may be listed on the Match Record. All Teams competing in reserves Competition Fixtures are permitted to name six (6) substitutes and use a maximum of five (5) substitutes throughout that Competition Fixture.
- 11.1.3. All substitutes must be seated within the Technical Area.

11.2. Additional Time

- 21.2.1. Additional Time for Men’s State Leagues must be played in accordance with the IFAB Laws of The Game.

11.3. Match Balls

- 11.3.1. The Home Club shall provide the Match Official with three (3) match balls (size 5) no later than 30 minutes prior to the start of the scheduled Competition Fixture.
- 11.3.2. All Clubs must use a licensed match ball from one (1) of FV’s licensed ball manufacturers as advised by FV from time to time.
- 11.3.3. Any breach of the match ball licensing arrangements must be reported to FV by the Match Official.
- 11.3.4. A failure to comply with Regulation 11.3 may result in a fine as set out in the GDT.

11.4. Results of Competition Fixtures

- 11.4.1. *State League Seniors and Reserves – Minimum Requirements to be entered by the Home Club if no match official is present at the fixture.*
 - a. Home Team
 - (i) Half Time Score
 - (ii) Full Time Score
 - (iii) Home Team Player List
 - (iv) Home Team Goal Scorers
 - (v) Home Team Cautions
 - b. Away Team
 - (i) Away Team Player List
 - (ii) Away Team Goal Scorers
 - (iii) Away Team Cautions

11.4.2. *Results*

- a. All results including goal scorers, substitutions and cautions shall be submitted by the match official no more than 90 minutes following the conclusion of the Competition Fixture.
- b. All player lists must be submitted by the home/away team prior to the commencement of the match as part of the online match record process.

11.4.3. All results, cautions, substitutions (MSL only) best and fairest votes, reporting and player lists and goal scorers must be submitted via GameDay.

11.4.4. Clubs which fail to submit results, cautions and goal scorers (when requested or when a match official is not present) or player lists prior to the match commencing on the online match records template in accordance with Rule 11.4 may be fined or otherwise penalised for Misconduct under the GDT.

12.1. Admittance to Competition Fixtures

12.1.1. Team Admittance Passes

- MSL 1 – 3 Clubs will be provided with 50 admittance passes for season 2023.
- Admittance passes must be displayed upon entry by the visiting Team’s players on the day of the Competition Fixture.
- Admittance passes only entitle the bearer admittance to the Division in which the player or Club is participating in that Regular Season.
- In the event of any Competition Fixture for which admission cannot be charged (such as junior fixtures) and a MSL1-3 Competition Fixture being played at the same venue on the same day, no persons attending for the purpose of the non MSL1-3 Competition Fixture can be charged for entry into the venue.

d. MSL4 & MSL5

No admission fees may be charged

12.1.3. *Car Parking*

No Club may charge for car parking at any Men’s State League Competition Fixture.

12.2. **Media and Other Passes**

12.2.1. FV may withdraw an FV Media Pass at any time.

12.2.2. No Club may refuse entry to a holder of a current FV Season or FA Media Pass without FV’s prior written consent, or unless this person demonstrates an immediate security threat.

13. MATCH OFFICIAL RESPONSIBILITIES

13. MATCH OFFICIAL RESPONSIBILITIES

13.1. Best and Fairest Votes

- 13.1.1. At the conclusion of each senior Competition Fixture, the Match Official must complete the Best and Fairest Votes and submit those votes to FV through the Online Match Record process within 24 hours.
- 13.1.2. All votes must be recorded on GameDay as part of the online match records process.
- 13.1.3. All votes must be treated with the highest confidentiality.
- 13.1.4. Votes shall be cast in a 3-2-1 format with three (3) votes given to the player adjudged by the Match Official to be the best and fairest in each Competition Fixture.
- 13.1.5. A failure to comply with Rule 13.1.1 may result in a Match Official being suspended from officiating or demoted to a lower panel.
- 13.1.6. A player who receives a Suspension (as defined in the GDT) in a Competition Fixture during the Regular Season (excluding Play Off and Finals matches) shall be ineligible to win a Best and Fairest award in any given Regular Season. To avoid doubt this includes but is not limited to a player who receives ten (10) Yellow Cards or more in a Regular Season.
- 13.1.7. A player who has a Direct Red Card revoked for mistaken identity shall be otherwise eligible to win a Best and Fairest award.
- 13.1.8. Best and Fairest awards will not apply in reserves Leagues.
- 13.1.9. In the event of no FV appointed Match Official, no Best and Fairest votes will be awarded for that Competition Fixture.
- 13.1.10. If two (2) or more Players have the same number of Best and Fairest votes at the conclusion of the Regular Season, multiple Best and Fairest winners will be awarded for those League(s).
- 13.1.11. Players that have played at more than one Club or have played in more than one League in the 2023 season will have goals and/or votes recognised as follows:
 - a. Votes and/or goals in multiple Leagues: The player's goals and/or votes earned in each League will be considered separate and do not carry over, irrespective of whether they were earned with the same Club or after transferring from one Club to another.

Example 1: Votes awarded to a player in MSL1NW cannot be counted in the final tally for the Best and Fairest Award for MSL2SE in that Regular Season.
 - b. Votes and/or goals at multiple Clubs in the same League: Subject to Rules 2.1.3 and 2.1.4, if a player plays for more than one Club in the same League in the same Regular Season, the player's goals/votes are tallied together, however the player will only be recognised in terms of his award as a player for the Club at which the player finishes the Regular Season.

Example 2: Votes awarded to the same player whilst playing for multiple Clubs in MSL3NW will be tallied together for the purposes of the Best and Fairest Award for MSL3NW in that Regular Season.

14. MEN’S STATE LEAGUE FINALS/PLAYOFF SERIES

14. MEN’S STATE LEAGUES FINALS SERIES

14.1. Competition Format

- 14.1.1. MSL1-5 Divisions and Leagues may conclude the Regular Season with a Finals/Playoff series.
- 14.1.2. The Premier of MSL1 South-East may play the Premier of MSL1 North-West to determine the State League 1 Champion.
- 14.1.3. The Premier of MSL2 South-East may play the Premier of MSL2 North-West to determine the State League 2 Champion.
- 14.1.4. The Premier of MSL3 South-East may play the Premier of MSL3 North-West to determine the State League 3 Champion.
- 14.1.5. The Premier of MSL4 South may play the Premier of MSL4 East to qualify for the State League 4 Grand Final.
- 14.1.6. The Premier of MSL4 North may play the Premier of MSL4 West to qualify for the State League 4 Grand Final.
- 14.1.7. The winners of the Finals outlined in Rules 14.1.5 and 14.1.6 may play in the State League 4 Grand Final. The winner of the State League 4 Grand Final will be the State League 4 Champion.
- 14.1.8. The Premier of MSL5 South may play the Premier of MSL5 East to qualify for the State League 5 Grand Final.
- 14.1.9. The Premier of MSL5 North may play the Premier of MSL5 West to qualify for the State League 5 Grand Final.
- 14.1.10. The winner of the Finals outlined in Rules 14.1.8 and 14.1.9 may play in the State League 5 Grand Final. The winner of the State League 5 Grand Final will be the State League 5 Champion.
- 14.1.11. The selection of venues for the 2023 MSL Finals Series will be determined at the absolute discretion of FV.
- 14.1.12. If any 2023 MSL Finals Series match is postponed, abandoned or cancelled, that Final will be played within three (3) days of the original Final date at the absolute discretion of FV. This may include the Final being played the following day, and/or the Final being played at an alternative venue.
- 14.1.13. Subject to this Regulation or unless otherwise determined by FV acting in its absolute discretion, the Team winning the Finals at the conclusion of the Regular Season may entitle the Team to be named Champions. For the avoidance of doubt simply winning the final does not entitle the Team to be named Champions.

14. MEN’S STATE LEAGUE FINALS/PLAYOFF SERIES

14.2. Procedures to Determine the Winner of Finals / Play Off Matches

- 14.2.1. All Finals in the 2023 MSL Finals Series will be played over one (1) leg.
- 14.2.2. If, at the conclusion of Normal Time in any Final, the scores between the Teams are tied, then extra time of two (2) equal periods of 15 minutes will be played in accordance with the IFAB Laws of The Game.
- 14.2.3. If scores remain equal at the conclusion of both periods of extra time, penalty kicks will be taken in accordance with the IFAB Laws of the Game to determine the winner of the Final.

14.3. Discipline

- 14.3.1. Yellow cards accumulated by a player during the MSL Finals Series will not be counted for the purposes of clause 4.3.a of the GDT. However, if a player receives their 5th yellow card in their Team’s final Regular Season Competition Fixture, clause 4.3.a. of the GDT will apply and that player will be suspended for their first Final of the 2023 MSL Finals Series for the relevant Division.

14.4 Player Restrictions

- 14.4.1 Each player must have played at least five (5) Regular Season Competition Fixtures for that Team to qualify to play Finals & Playoffs in 2023 for that Team.
- 14.4.2 Competition Fixtures played by a player in either the reserve or senior Teams for a Club count towards the player eligibility requirements listed in Rule 14.4.1.
- 14.4.3 FV will only consider an exception to Rule 14.4.1 in exceptional circumstances and where a Club/Team can establish that it is unable to field a Team for a Final (in compliance with Rule 14.4.1) due to insufficient player numbers as a result of availability (including injury). Any Club wishing to rely on Rule 14.4.3 must apply to FV:
 - a. in writing;
 - b. at least five (5) days before the Final is due to take place;
 - c. setting out the reasons it requests an exception be granted to Rule 14.4.1, providing evidence in support of player unavailability; and
 - d. provide FV with any further information required.
- 14.4.4 FV will consider any request made in accordance with Rule 14.4.3 together with all information provided in support of that request and make a decision regarding any exception requested. Any decision made in this regard is at the absolute discretion of FV and is not subject to review or appeal.

15. COMPETITION STRUCTURE

15.1. General Information

- 15.1.1. These Regulations shall apply to all women’s senior and reserve grade fixtures within the following metropolitan FV Competitions.

- 15.1.2. Number of teams is determined by FV in its absolute discretion.
- a. FV will determine the Victorian Premier League Womens and Women’s State League structures at their absolute discretion.
- 15.1.3. FV reserves the right in its absolute discretion to amend the structure of Community Competitions, including the number of Clubs in each Division, before, during or after the Regular Season, as a result of FA actions, including the establishment of any new or varied FA auspiced Leagues or Divisions, or compulsory Player pathways.
- 15.1.4. Any promotion and relegation provisions referred to in Rule 15 are subject to Community Competitions continuing in 2023 in the same, or substantively the same, structure. For the avoidance of doubt any promotion and relegation of teams is at the absolute discretion of FV. There is no right to promotion.
- 15.1.5. FV reserves the right to determine dates and times of Competition Fixtures with specific regards to the number of matches played within the immediate proximity of the relevant Competition Fixture; including but not limited to Nike Cup FC commitments.
- 15.1.6. Subject to these Rules and Regulations, at the end of the Regular Season including any Finals or Play Off Matches, the final standings of each League will determine which Teams may have the right to be promoted or relegated between Divisions. A Team that earns the right to be promoted shall only be promoted for the following season provided it:
- a. has no outstanding debts to FV;

15. COMPETITION STRUCTURE

- b. has complied with any Rules or Regulations for Teams participating in the relevant League or Division including but not limited to those relating to facility and pitch requirements by the date prescribed by FV from time to time; and
 - c. is not otherwise in breach of these Rules and/or Regulations or any other requirements of FV.
- 15.1.7. Competition Fixtures may only be played on public holidays with the permission of FV.
- 15.1.8. All senior and reserves Teams will play on the same day with all reserve Competition Fixtures played as a curtain raiser to the senior Competition Fixture on that day, unless otherwise determined by FV.
- 15.1.9. To be eligible to participate in senior women’s competitions run by FV, a player must be at least 14 years of age as at 1 January 2023, unless an application to FV for exemption from Rule 15.1.9 is made by the player’s Club on behalf of a player and is accepted by FV.
- 15.1.10. An application made under Rule 15.1.9 must meet the following minimum criteria:
 - a. the application must be supported by a signed letter from the player’s Club president supporting the application;
 - b. the application must be supported by a signed letter from the player’s State Team/Representative Team coach or Club Technical Director;
 - c. the application must be supported by a signed letter of consent from the player’s parent or guardian supporting the application;
 - d. the application must be supported by a signed letter of support from the player’s medical professional listing general medical details of the player including height and weight; and
 - e. the Club/player must provide FV with any further information requested.
- 15.1.11. An application made under Rule 15.1.9 will be considered by FV. FV has absolute discretion in relation to any application made under that Regulation.
- 15.1.12. VPLW Clubs will only be permitted to list four (4) Visa players however, at least one (1) of these must have a nationality of an AFC Member Association (3+1 AFC Visa Ruling) on their Senior match day team sheet.
- 15.1.13. Any VPLW Club that lists more than four (4) Visa players (3+1 AFC Visa Ruling) on their Senior team match day team sheet will be in breach of Rule 15.1.12 and may be in breach of Rules regarding fielding an ineligible player(s).
- 15.1.14. It is entirely the Clubs responsibility to ensure players are eligible in relation to the 3+1 AFC Visa ruling.
- 15.1.15. Where a Club which does not hold a Senior NPLW Participation Licence, that Club may field Players up in age groups from its JGNPL teams (Under 13 – Under 17) into its Victorian Premier League Womens (VPLW) competition teams as follows:
 - a. Unlimited players from a Junior Girls NPL Roster can play up per fixture at one time in the Club’s reserves or senior women’s VPLW competitions teams. Players must be 14 years of age as at 1 January 2023 to be eligible to participate in the reserves or senior women’s competitions.

15. COMPETITION STRUCTURE

15.2. Multiple Teams in VPLW/Women’s State League Structure

- 15.2.1. Club’s may enter more than one Team in the FV Women’s State League Divisions provided that:
 - a. No more than one Team from a particular Club may participate in the National Premier League Womens, Victorian Premier League Womens and Women’s State League 1 Division in any given Regular Season;
 - b. No more than one Team from a particular Club may participate in a particular League in any given Regular Season;
 - c. Clubs with multiple Teams in the FV Women’s State Leagues must comply with the player eligibility Rules as set out in Rules 15.2.2 to 15.2.6 below.
- 15.2.2. Once a Player has played six (6) or more Competition Fixtures for the Team entered by her Club in the higher Division of Women’s State Leagues or VPLW (of the multiple Teams entered by that Club in any given Regular Season), that Player is ineligible to play in any Competition Fixture for any Team entered by that Club in a lower or equal Division for the remainder of the Regular Season (including any Play Off Matches or Finals).
 - a. Competition Fixtures played by a player in either the reserves or seniors for the Team entered by her Club in the higher Division of Women’s State Leagues and VPLW count towards the player eligibility listed in Rule 15.2.2.
- 15.2.3. Dispensation from Rule 15.2.2 may be provided on the basis of long-term injury or illness (minimum five (5) weeks). Medical evidence to support a dispensation application will be required and any decision in this regard will be made at the absolute discretion of FV and will be final.
- 15.2.4. If a Club has two (2) or more Teams in the same Women’s State League Division (but different Leagues), Players for those Teams are Team-tied from the sixth (6th) round Competition Fixture of the Regular Season.
- 15.2.5. Clubs with two (2) or more Teams in the same Women’s State League Division (and therefore with Team-tied Players) must submit a Team list for each of those Teams to FV prior to their seventh (7th) round fixture, listing the players within their designated Team.
 - a. Any new player joining one of those Teams after the sixth (6th) round must be allocated to (and can only play for) one (1) of the tied-Teams for the remainder of the Regular Season.
- 15.2.6. There is no restriction on movement of players between reserve and senior Teams for the same Club in the one (1) League.

15.3. Women’s Victorian Premier League & Women’s State League 1

- 15.3.1. VPLW shall comprise of 12 Teams, or such other number as determined by FV from time to time.
- 15.3.2. VPLW Teams will play each other on a home and away basis over 22 Rounds unless otherwise determined by FV in its absolute discretion.
- 15.3.3. WSL1NW and WSL1SE shall comprise 10 Teams each, or such other number as determined by FV from time to time.
- 15.3.4. WSL1 Teams will play each other on a home and away basis over 18 Rounds unless otherwise determined by FV in its absolute discretion.

15. COMPETITION STRUCTURE

15.3.5. Each VPLW and WSL1 Club shall:

- a. field a senior Team and a reserves Team;
- b. provide for all home FV Competition Fixtures a pitch which complies with the requirements of Rule 3.1;
- c. other than FV representative Teams, field and maintain in FV Competitions not less than two (2) Junior Girls or Girls MiniRoos Teams (Under 8’s - Under 19’s).

15.3.6. Failure to comply with Rule 15.3.3. may result in the imposition of a penalty under the GDT or further sanctions as determined by FV.

15.3.7. Failure by a Club to comply with FV Registration Regulations regarding minimum player requirements for VPLW and WSL1; i.e. to be able to field senior and reserves Teams, may result in the Club forfeiting its position in the VPLW and WSL1 competition, in which case the Club may be relegated to a lower Division at FV’s discretion.

15.3.8. Subject to this Regulation or unless otherwise determined by FV acting in its discretion the Teams finishing 1st in the VPLW, WSL1NW and WSL1SE seniors and reserves competitions at the conclusion of the Regular Season, may be crowned Premiers of those Leagues and the 2nd placed Team may be crowned Runner-up respectively. For the avoidance of doubt, simply finishing first or second place on the ladder does not entitle the Team to be named Premiers or Runners Up. There will be no Finals series for reserves competitions in VPLW/WSL1.

15.4. Women’s State League 2 - 5

15.4.1. All WSL2-5 Teams in all Leagues will play each other on a home and away basis over 18 rounds unless otherwise determined by FV in its absolute discretion.

15.4.2. Clubs competing in all WSL2-5 Leagues are only required to field a senior Team.

15.4.3. Subject to this Regulation or unless otherwise determined by FV acting in its discretion the Team finishing 1st in each League of WSL2-5 at the conclusion of the Regular Season may be crowned League Premiers and the 2nd placed Team may be crowned Runner-up. For the avoidance of doubt, simply finishing on first or second place on the ladder does not entitle the Team to be named Premiers or Runners Up.

15.5. Promotion and Relegation

15.5.1. The Premier and Runner-up of VPLW at the end of the VPLW Regular Season may be eligible for promotion from VPLW to NPLW in the following season, provided those Clubs meet the requirements outlined in the NPLW license agreement as promulgated by FV from time to time.

15.5.2. To be eligible for promotion into NPLW, Clubs will be required to adhere to the licensing requirements for that level of competition. FV reserves the right to review Clubs who cannot meet the criteria. Clubs who breach or cannot meet the criteria may be fined, removed, or not offered a position into that tier of competition.

15.5.3. Those Clubs finishing in second last and last position of VPLW may be relegated to WSL1 for the following season.

15.5.4. The Premier of each League (NW and SE) of WSL1 may be eligible for promotion to VPLW for the following season.

15.5.5. Those Clubs finishing in last position of each League (NW and SE) of WSL1 may be relegated to WSL2 for the following season.

15. COMPETITION STRUCTURE

- 15.5.6. The Premier of each League (NW and SE) of WSL2 may be eligible for promotion to WSL1 in the following season.
- 15.5.7. Those Clubs finishing in second last and last position of each League (NW and SE) of WSL2 may be relegated to WSL3 for the following season.
- 15.5.8. The Premier of each League (N, W, S and E) of WSL3 may be eligible for promotion to WSL2 in the following season.
- 15.5.9. Those Clubs finishing in last position of each League (N, W, S and E) of WSL3 may be relegated to WSL4 for the following season.
- 15.5.10. The Premier of each League (N, W, S and E) of WSL4 may be eligible for promotion to WSL3.
- 15.5.11. Those Clubs finishing in last position of each League (N, W, S and E) of WSL4 may be relegated to WSL5 for the following season.
- 15.5.12. The Premier of each League (N, W, S and E) of WSL5 may be eligible for promotion to WSL4.
- 15.5.13. The Women’s State League promotion and relegation positions are determined based on the team entries into the current league structures, should the league structures change based on team entries the promotion and relegation positions will also be amended at FV’s discretion.
- 15.5.14. A Club promoted or relegated in accordance with Rule 15.5 will not automatically be promoted or relegated into the corresponding League in the Division above or below. For example, a Club promoted from WSL4 North will not automatically be promoted to WSL3 North. Decisions regarding League positioning will be made by FV at its discretion and in the best interests of League and Division structures for the following season.
- 15.5.15. To be eligible for promotion into NPLW, VPLW or Womens State Leagues clubs will be required to adhere to the licensing or competition requirements for that level of competition. FV reserves the right to review clubs who cannot meet the criteria. Clubs who breach or cannot meet the criteria may be fined, removed, or not offered a position into that tier of competition.
- 15.5.16. All Promotion and Relegation Regulations outlined in Rule 15.5 are based on the continuation of the current FV Competition structure for the Women’s State League. FV reserves the right to alter any competition structure for the following Regular Season. Any vacancy created as a result of such a restructure may be filled in accordance with these Rules and Regulations.
- 15.5.17. Promotion and relegation positions are at the absolute discretion of FV and may be amended at any time prior to the commencement of the competition season, during the competition season or post competition season.

15.6. New Teams/New Division/New Leagues

- 15.6.1. All Clubs may apply to enter a new Team or Teams into WSL. FV will determine all applications in its absolute discretion and its decision is not appealable. Any Team entered in WSL will automatically be placed into the lowest Division of WSL (currently WSL5) unless otherwise determined by FV.

15. COMPETITION STRUCTURE

- 15.6.2. FV reserves its right at the conclusion of the 2023 Regular Season to establish one or more of the following:
- a. A Women’s State League 6 Division; and/or
 - b. A Women’s Metropolitan Division.
- 15.6.3. A decision made under Rule 15.6.2 may depend on but is not limited to the number of Club and Team entries for senior women’s football in 2023. Further, the placement of Teams in either of the Divisions referred to in Rule 15.6.2 will be determined, at least in part, by the finishing position(s) of those Teams at the conclusion of the 2023 Regular Season, where applicable.

15.7. Vacancies in VPLW/Women’s State League

- 15.7.1. From time to time vacancies are created in VPLW and WSL Divisions due to:
- a. a Team withdrawing from VPLW or a WSL Division or League;
 - b. a Team being expelled from VPLW or a WSL Division or League;
 - c. a Team being deemed ineligible for promotion as a result of a breach of, or non-compliance with, these Rules and Regulations;
 - d. a Team being relegated as a result of a breach of these Rules and Regulations;
 - e. FV acting in its discretion may permit a club to self-relegate from their current Competition for the following season provided it received notification from the club no later than 28 days from the conclusion of the regular season; or
 - f. other reasons from time to time.
- 15.7.2. If a vacancy is created in VPLW or a WSL Division prior to the commencement of the Regular Season (whether that vacancy is created during the previous season or in the ‘off-season’ prior to the commencement of the Regular Season in question), FV have absolute discretion when filling a vacancy. FV may choose to leave the vacancy and replace it with a bye, fill the vacancy by offering it to Clubs in accordance with the priority set out in Rules 15.7.3 and 15.7.4 or decide upon an alternate outcome in FV’s absolute discretion.
- 15.7.3. Vacancies created in accordance with Rules 15.7.1 and 15.7.2 will be filled in the following order of priority:
- a. The highest finishing Team which is to be, or has been, relegated in accordance with these Regulations from the Division in which the vacancy arises;
 - b. If applicable, the highest finishing loser of the Play Off Finals matches referred to in Rule 15.5 (if relevant);
 - c. Any remaining Teams which are to be, or have been, relegated in accordance with these Rules from the Division in which the vacancy arises in order of merit;
 - d. The highest finishing Team (based on order of merit) which misses out on promotion in accordance with these Rules, from the Division below the Division in which the vacancy arises; and
 - e. Remaining Teams which miss out on promotion in accordance with these Rules, from the Division below the Division in which the vacancy arises in order of merit.

15. COMPETITION STRUCTURE

- 15.7.4. In deciding on order of merit for the purposes of Rule 15.7.3 or where two teams are otherwise equal for the purposes of Rule 15.7.3, those Teams will be ranked according to the following (and in this order):
- a. league finishing position for the respective teams;
 - b. average points per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - c. average Goal Difference per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - d. average goals FOR per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled); or
 - e. the Team and the Club’s disciplinary record for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled).
- 15.7.5. If Teams cannot be separated under Rule 15.7.4 then those Teams may be required to play a Play Off Match in circumstances where they both seek promotion to the higher Division in question.
- 15.7.6. FV, acting in its discretion, may decide not to fill a vacancy in VPLW or WSL where doing so would disrupt lower Leagues and/or Divisions, for example where a League vacancy is created in close proximity to the start of the Regular Season.

15.8. Scheduling of Matches – Days of Play

- 15.8.1. VPLW/WSL Competition Fixtures will be played on either Friday, Sunday or Monday, although FV may schedule Competition Fixtures on other days as it deems necessary, or otherwise approves.
- 15.8.2. Friday or Monday night FV Competition Fixtures may not kick off earlier than 6.15pm (Reserves) or 8.30pm (Seniors), unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 15.8.3. VPLW/WSL Competition Fixtures cannot be scheduled for a Friday or Monday night if the distance between the home venues of the two (2) Clubs exceeds 50km, unless upon written agreement of the two (2) Clubs or determined by FV at its absolute discretion.
- 15.8.4. Sunday FV Competition Fixtures may not:
- a. Kick off earlier than 11.00am (reserves) or 1.00pm (seniors) unless either Competition Fixture has been rescheduled according to Rule 4.3.
 - b. Kick off later than 6.30pm (reserves) or 8.30pm (seniors), unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 15.8.5. The applicable kick off times for Sunday Competition Fixtures apply to any Competition Fixtures held on public holidays.

16. FIXTURE REQUIREMENTS

16. FIXTURE REQUIREMENTS

16.1. Interchange

16.1.1. Victorian Premier League Womens/Women’s State Leagues

- a. A maximum of seventeen (17) players may be named on the Match Record. Clubs may make any number of interchanges during the course of the Competition Fixture, provided the Match Official has been consulted first.
- b. A Match Official may decline the interchange of players in the last five (5) minutes of the second half of a Competition Fixture if in his or her opinion the change is being made to deliberately delay play.
- c. All substitutes must be seated within the Technical Area.

16.2. Additional Time

- 16.2.1. Additional Time for VPLW and WSL must be played in accordance with the IFAB Laws of The Game.

16.3. Match Balls

- 16.3.1. The Home Club shall provide the appointed Match Official with three (3) match balls (size 5) no later than 30 minutes prior to the start of the scheduled Competition Fixture.
- 16.3.2. All Clubs must use a licensed match ball from one (1) of FV’s licensed ball manufacturers as advised by FV from time to time.
- 16.3.3. Any breach of the match ball licensing arrangements must be reported to FV by the Match Official.

16.4. Results of FV Competition Fixtures

- 16.4.1. *Senior and Reserve Leagues – Minimum Requirements if no match official is present at the fixture.*
 - a. Home Team
 - (i) Half Time Score
 - (ii) Full Time Score
 - (iii) Home Team Player List
 - (iv) Home Team Goal Scorers
 - (v) Home Team Cautions
 - b. Away Team
 - (i) Away Team Player List
 - (ii) Away Team Goal Scorers
 - (iii) Away Team Cautions

16. FIXTURE REQUIREMENTS

16.4.2. Results

- a. All results including goal scorers, substitutions and cautions shall be submitted by the match official no more than 90 minutes following the conclusion of the Competition Fixture.
- b. All player lists must be submitted by the home and away team prior to the commencement of the match as part of the online match record process.

16.4.3. All results, cautions, substitutions, best and fairest votes, reporting and player lists and goal scorers must be submitted via GameDay.

16.4.4. Clubs which fail to submit results, cautions and goal scorers (when requested or when a match official is not present) or, player lists prior to the match commencing on the online match record template in accordance with Rule 16.3 may be fined or penalised for Misconduct under the GDT.

18. MATCH OFFICIAL RESPONSIBILITIES

18. MATCH OFFICIAL RESPONSIBILITIES

18.1. Best and Fairest Votes

- 18.1.1. At the conclusion of each senior VPLW and WSL Competition Fixture, the Match Official must complete the Best and Fairest Votes and submit these to FV within 24 hours of the fixture completion.
- 18.1.2. All votes must be recorded on GameDay through the online match record process.
- 18.1.3. All votes must be treated with the highest confidentiality.
- 18.1.4. Votes shall be cast in a 3-2-1 format with three (3) votes given for the player adjudged by the Match Official to be the best and fairest in each Competition Fixture.
- 18.1.5. A failure to comply with Rule 18.1 may result in a Match Official being suspended from officiating or demoted to a lower Division.
- 18.1.6. A player who receives a Suspension (as defined in the GDT) in a Competition Fixture during the Regular Season (excluding Play Off and Finals matches) shall be ineligible to win a Best and Fairest award in any given Regular Season. To avoid doubt this includes but is not limited to a player who receives ten (10) Yellow Cards or more in a Regular Season.
- 18.1.7. A player who has a Direct Red Card revoked for mistaken identity shall be eligible to win a Best and Fairest award.
- 18.1.8. Best and Fairest awards will not apply in Reserves Leagues.
- 18.1.9. In the event of no FV appointed Match Official, no Best and Fairest votes will be awarded for that Competition Fixture.
- 18.1.10. If two (2) or more players have the same number of Best and Fairest votes at the conclusion of a Regular Season, multiple Best and Fairest winners will be awarded for the relevant League.
- 18.1.11. Players that have played at more than one Club or have played in more than one League in the 2023 season will have goals and/or votes recognised as follows:
 - a. Votes and/or goals in multiple Leagues: the player's goals and/or votes earned in each League will be considered separate and do not carry over, irrespective of whether they were earned with the same Club or after transferring from one Club to another.

Example 1: Votes awarded to a player in WSL1NW cannot be counted in the final tally for the Best and Fairest Award for WSL2SE in that Regular Season.
 - b. Votes and/or goals at multiple Clubs in the same League: if a player plays for more than one Club in the same League in the same Regular Season, the player's goals/votes are tallied together, however the player will only be recognised in terms of her award as a player for the Club at which she finishes the Regular Season.

Example 2: Votes awarded to the same player whilst playing for multiple Clubs in WSL3N will be tallied together for the purposes of the Best and Fairest Award for WSL3N in that Regular Season.

19. VPLW/WSL FINALS SERIES

19. VPLW/WSL FINALS SERIES

19.1. Competition Format

- 19.1.1. All VPLW/ WSL senior competitions may conclude the Regular Season with a Finals series.
- 19.1.2. The VPLW finals may follow the finals format outlined below:

The Teams finishing in positions 1 to 4 at the conclusion of the VPLW Regular Season may qualify for the VPLW finals. The VPLW Finals Series may be contested as follows:

 - a. *Week 1*
 - (i) 1st place may have the opportunity to host 4th place with the winning Team advancing to the Grand Final, losing team is eliminated.
 - (ii) 2nd place may have the opportunity to host 3rd place, the winning Team will then compete in the Grand Final, losing team is eliminated;
 - b. *Week 2*
 - (i) The Grand Final between the winners of the matches outlined in Rule 19.1.3 a (i) and 19.1.3 a (ii)
 - (ii) The Grand Final will be hosted at an FV appointed venue.
 - c. Subject to this Regulation or unless otherwise determined by FV acting in its discretion the winner of the Grand Final may be crowned the Champion of the VPLW league. For the avoidance of doubt, simply winning the Grand Final does not entitle the Team to be named Champions.
- 19.1.3. The Premier of WSL1 South-East may play the Premier of WSL1 North-West to determine the Women’s State League 1 Champion.
- 19.1.4. The Premier of WSL2 South-East may play the Premier of WSL2 North-West to determine the Women’s State League 2 Champion.
- 19.1.5. The Premier of WSL3 South may play the Premier of WSL3 East to qualify for the Women’s State League 3 Grand Final.
- 19.1.6. The Premier of WSL3 North may play the Premier of WSL3 West to qualify for the Women’s State League 3 Grand Final.
- 19.1.7. The winner of the Finals outlined in Rules 19.1.5 and 19.1.6 may play in the Women’s State League 3 Grand Final. The winner of the Women’s State League 3 Grand Final may be the Women’s State League 3 Champion.
- 19.1.8. The Premier of WSL4 South may play the Premier of WSL4 East to qualify for the Women’s State League 4 Grand Final.
- 19.1.9. The Premier of WSL4 North may play the Premier of WSL4 West to qualify for the Women’s State League 4 Grand Final.
- 19.1.10. The winner of the Finals outlined in Rules 19.1.8 and 19.1.9 may play in the Women’s State League 4 Grand Final. The winner of the Women’s State League 4 Grand Final may be the Women’s State League 4 Champion.
- 19.1.11. The Premier of WSL5 South may play the Premier of WSL5 East to qualify for the Women’s State League 5 Grand Final.

19. VPLW/WSL FINALS SERIES

- 19.1.12. The Premier of WSL5 North may play the Premier of WSL5 West to qualify for the Women’s State League 5 Grand Final.
- 19.1.13. The winner of the Finals outlined in Rules 19.1.11 and 19.1.12 may play in the Women’s State League 5 Grand Final. The winner of the Women’s State League 5 Grand Final maybe the Women’s State League 5 Champion.
- 19.1.14. Subject to this Regulation and unless otherwise determined by FV acting in its absolute discretion, the Team winning the Finals at the conclusion of the Regular Season may entitle the Team to be named Champions. For the avoidance of doubt simply winning the final does not entitle the Team to be named Champions.
- 19.1.15. The selection of venues for all 2023 VPLW/WSL1-5 Finals will be determined at the absolute discretion of FV.
- 19.1.16. The Women’s State League finals structure is determined based on the team entries into the current league structures, should the league structures change based on team entries the finals series format may also be amended at FV’s discretion.
- 19.1.17. If any 2023 VPLW/WSL 1-5 Finals match is postponed, abandoned or cancelled, that Final may be re-played at a time and venue to be determined by FV.
- 19.1.18. FV will cover all Match Official Match Fees for all 2023 VPLW/WSL1-5 Finals matches.

19.2. Procedures to Determine the Winner of Finals

- 19.2.1. All Finals played in the 2023 VPLW/ WSL Finals Series will be played over one (1) leg.
- 19.2.2. If, at the conclusion of any Final, the scores between the Teams are tied, then extra time of two (2) equal periods of 15 minutes will be played in accordance with IFAB Laws of The Game.
- 19.2.3. If scores remain equal at the conclusion of both periods of extra time, penalty kicks will be taken in accordance with the IFAB Laws of the Game to determine the winner of the Final.

19.3. Discipline

- 19.3.1. Yellow cards accumulated by a player during the WSL Finals Series will not be counted for the purposes of clause 4.3.a of the GDT. However, if a player receives their 5th yellow card in their Club’s final Regular Season Competition Fixture she shall be suspended for their first Competition Fixture of the 2023 Women’s State League Finals Series.

19.4. Player Restrictions

- 19.4.1 Each player must have Played at least five (5) Regular Season Competition Fixtures for that Team to qualify to play Finals & Playoffs in 2023 for that Team.
- 19.4.2 Competition Fixtures played by a player in either the reserve or senior Teams for a Club count towards the player eligibility requirements listed in Rule 19.4.1
- 19.4.3 FV will only consider an exception to Rule 19.4.1 in exceptional circumstances and where a Club/Team can establish that it is unable to field a Team for a Final (in compliance with Rule 19.4.1) due to insufficient player numbers as a result of availability (including injury). Any Club wishing to rely on Rule 19.4.3 must apply to FV:
 - a. in writing;
 - b. at least five (5) days before the Final is due to take place;

- c. setting out the reasons it requests an exception be granted to Rule 19.4.1, providing evidence in support of player unavailability; and
 - d. provide FV with any further information required.
- 19.4.4 FV will consider any request made in accordance with Rule 19.4.3 together with all information provided in support of that request and make a decision regarding any exception requested. Any decision made in this regard is at the absolute discretion of FV

20. COMPETITION STRUCTURE

20.1. General Information

- 20.1.1. These Regulations shall apply to all junior metropolitan Competition Fixtures.
- 20.1.2. Player ID cards (ID Cards) generated through Play Football are required in all junior Competition Fixtures. For clarity:
 - a. ID Cards must include an eligible photo uploaded to Play Football.
 - b. An ID Card with a photo attached after printing of the card will be deemed to be invalid.
 - c. ID Cards presented in an electronic form, including but not limited to smart phones, tablets, laptops and computers are valid.
 - d. Photocopied ID cards will be deemed invalid.
- 20.1.3. FV will determine the Junior League structures at their absolute discretion. Where team numbers permit, Junior Leagues will be divided into the following zones:
 - a. West
 - b. North
 - c. East
 - d. South
- 20.1.4. In circumstances where team numbers entered into a particular junior age group do not allow viable zonal Leagues, FV may amalgamate available Teams into one or more of the following competitions:
 - a. Metropolitan (stand-alone)
 - b. North-West
 - c. South-East
 - d. Any other zone that FV determines in its absolute discretion based on team numbers entered.
- 20.1.5. Based on the final standings from the 2022 season, the top five (5) teams from each "A" League (West, North, East & South) will be allocated to create North-West & South-East Leagues for the 2023 season.
- 20.1.6. All remaining teams within the "A" League will be allocated as per Rule 20.1.3 & 20.1.4 if required.
- 20.1.7. Junior Competition Fixtures will only be played on Sunday although FV may schedule Competition Fixtures on other days as it deems necessary, or otherwise approves.
- 20.1.8. Under 20 and Under 21 Competition Fixtures will be played on either Friday, Saturday, Sunday or Monday, although FV may schedule Competition Fixtures on other days as it deems necessary, or otherwise approves.

SCHEDULE 3 – 2023 METROPOLITAN JUNIOR COMPETITION REGULATIONS

20. COMPETITION STRUCTURE

- 20.1.9. Friday or Monday night Competition Fixtures may not kick off earlier than 6.15pm or later than 8.30pm unless the Competition Fixture has been rescheduled in accordance with Rule 4.3.
- 20.1.10. Competition Fixtures cannot be scheduled for a Friday or Monday night if the distance between the home venues of the two (2) Clubs exceeds 50km, unless written agreement from the two (2) Clubs is received or as determined by FV at its absolute discretion.
- 20.1.11. A player may only play up to four (4) years above his or her age group, or in the case of Under 20s and Under 21s the player must turn 15 years of age in 2023, unless an application to FV for exemption from Rule 20.1.11 is made by the player's Club on behalf of the player and is accepted by FV.
- 20.1.12. Any request for an exemption under Rule 20.1.11 must meet the following minimum criteria:
- a. the application must be supported by a signed letter from the player's Club president supporting the application;
 - b. the application must be supported by a signed letter from the player's State Team/Representative Team coach or Club Technical Director;
 - c. the application must be supported by a signed letter of consent from the player's parent or guardian supporting the application;
 - d. the application must be supported by a signed letter of support from the player's medical professional listing general medical details of the player including height and weight; and
 - e. the Club/player must provide FV with any further information requested.
- 20.1.13. Any application made under Rule 20.1.12 will be considered by FV. FV has absolute discretion in relation to any application made under that Rule.
- 20.1.14. A player who is participating above his or her age group will not be prevented from returning to play in his or her rightful age group unless that player is suspended.
- 20.1.15. For all Junior competitions, a player who has played at a higher division in a particular age group (e.g. 14As) for five (5) Competition Fixtures or more, cannot drop to a lower category (e.g. 14Bs) within the same age group for his or her Club for the remainder of the Regular Season (including Finals). This Rule does not, however, prevent a player who is playing 'up' an age group returning to his or her rightful age group in accordance with Rule 20.1.16.
- 20.1.16. A player may be granted a dispensation to play down a maximum of one (1) age group at FV's absolute discretion as per the regulations within the [FV Dispensation Policy](#).
- 20.1.17. FV may request information or clarification from a player or Club applying for dispensation under Rule 20.1.12 as it sees fit, and will make a decision in relation to the dispensation request at its absolute discretion.
- 20.1.18. FV may refuse to grant a dispensation requested at its absolute discretion and this decision is considered as final.

20. COMPETITION STRUCTURE

- 20.1.19. For under 12 – 21s Boys' & Girls' Competitions, if a Club has two (2) Teams in the 'A' and/or 'Kangaroos' division of a particular age group then players are 'team-tied' following completion of the fifth (5th) round of the Regular Season. Clubs will be required to submit a Team list for both Teams from Round 6 onwards, listing each player, which will be tied to that particular Team for the remainder of the Regular Season. Any new player(s) that are named on a Match Record for either of these Teams from Round 6 onwards, will be tied to that Team for the remainder of the Regular Season. Once a player is tied to a particular Team, the player must not be named on the Match Record for the clubs other 'A' and/or 'Kangaroos' division Team, otherwise they will be deemed ineligible.
- 20.1.20. Any junior competition with a flexible kick-off time may not kick-off earlier than 8:30am or later than 6:30pm unless the Competition Fixture has been rescheduled as per Rule 4.3, or as otherwise approved by FV in its absolute discretion.
- 20.1.21. Subject to these Regulations or unless otherwise determined by FV acting in its discretion the Teams finishing 1st in their relevant competition (e.g., Boys' North-West 13) at the conclusion of the Regular Season, may be crowned Premiers of those Leagues and the 2nd placed Team may be crowned Runners-up respectively. For the avoidance of doubt, simply finishing first or second place on the ladder does not entitle the Team to be named Premiers or Runners Up.
- 20.1.22. Where a Club holds a JBNPL Participation Licence and does not hold a Senior NPL Participation Licence, that Club may field Players up in age groups from its JBNPL Roster (Under 14 – Under 18) into its Community Teams as follows:
- A maximum of four (4) players from a JBNPL Roster can play up per fixture at one time in the Club's Under 20 or Under 21 Community Team.
 - Unlimited players from a JBNPL Roster can play up per fixture at one time for the Club's Reserves or Senior Men's Community Teams. Players must be of 15 years of age at 1 January 2023 to be eligible to participate in Reserves or Senior Men's Community Teams.

20.2. Junior Boys' Competition

- 20.2.1. Subject to Rules 20.1.11 and 20.1.14, players in the following age groups may take part in the Junior Boys' Competition 2023:

20.3.1. As an exception to the Venue Requirements as set out in Schedule 6, the Boys' and Girls' Under 12 & Under 13 competition in 2023 will be played as per Rule 20.3.1.

20.3.2. The offside rule will apply for under 12 and under 13 9v9 competition as per IFAB LOTG.

20.3.3. In accordance with IFAB LOTG, a penalty kick will be awarded if a player commits a direct free kick offence inside their penalty area.

- 20.3.4. The goalkeeper is allowed to handle the ball anywhere in the penalty area. To restart play after a save or gathering the ball with their hands, the ball must be thrown or rolled from the hands or played from the ground with their feet within 6 seconds, The goalkeeper is not allowed to kick or dropkick the ball from their hands.
- 20.3.5. Goal kicks can be taken from anywhere within the penalty area. Opponents must be outside the penalty area until the ball is in play. The ball is in play once it is kicked and leaves the penalty area.
- 20.3.6. Opponents must be at least 6 meters away from the ball until it is in play. The ball is in play when it is kicked and moves.
- 20.3.7. Red and Yellow Cards will be issued as per IFAB LOTG except in the following.
 - a. For any fouls that would ordinarily result in a red card, the match official will instruct the player to leave the field of play for the remainder of the match, any player sent from the field of play may be replaced by another player at the time of the offence. In this instance, neither team will be required to play with fewer than 9 players.

20.4. Under 21 Competition

- 20.4.1. Players born prior to 1st January 2002 will be deemed 'over age' players.
- 20.4.2. In the Under 21 Competition, Clubs may list and field a maximum of three (3) over age Players in any one (1) Competition Fixture.
- 20.4.3. In all Under 21 Competition Fixtures, Clubs must list each over age player on the Match Record by placing an asterisk next to that player's shirt number. Over age players are not required to present Player ID Cards.

20.5. Junior Girls' Competition

- 20.5.1. Subject to Rules 20.1.11 and 20.1.14 the Junior Girls' Competition will be played in the following age groups:

20.5.2. The preferred kick off times for Junior Girls' Competitions shall be as follows:

20.5.3. FV may alter kick off times of any Team within the Junior Girls' Competition upon the basis of a fixture clash or otherwise at its discretion.

20.5.4. As an exception to the Venue Requirements as set out in Schedule 6, the Girls' Under 12 and Under 13 competition in 2023 will be played as per this Rule 20.5.4. below:

20.6. Composition of Leagues

- Composition of Leagues is at the absolute discretion of FV.
- Any provisions referred to in Rule 20.6 are subject to Community Competitions continuing in 2023 in the same, or substantively the same structure.
- FV reserves the right to determine dates and times of Competition Fixtures with specific regards to the number of matches played.

20.6.1. Division Categories

- The categories in Under 12 Divisions (Boys and Girls) are Kangaroos, Wallabies and Joeys.
- The categories in Boys' Under 13 to Under 21 Divisions and Girls' Under 13, Under 14, Under 15, Under 16, Under 17/18 and Under 19 Divisions are A, B, C, D etc.

20. COMPETITION STRUCTURE

20.6.2. *League Size*

- a. FV's preferred League size for all junior leagues is ten (10) Teams to facilitate an eighteen (18) round Regular Season.
- b. In all Leagues for all age groups (Under 12 to Under 21) there may be a maximum of fifteen (15) and minimum of six (6) Teams playing an eighteen (18) round Regular Season, unless otherwise determined by FV.
- c. Teams in Leagues of an even (6, 8, 10, 12 or 14) number of Teams may all play 18 Competition Fixtures during the Regular Season unless otherwise determined by FV.
- d. Teams in Leagues of an uneven (7, 11, 13 or 15) number of Teams will either:
 - (i) have additional Competition Fixtures scheduled during their Regular Season; or
 - (ii) have Competition Fixtures removed from their Regular Season,
to ensure that all Teams play the same number of Competition Fixtures across the Regular Season.
- e. Teams in Leagues of nine (9) Teams may play sixteen (16) Competition Fixtures during the Regular Season unless otherwise determined by FV.

20.6.3. *Under 12 Boys' & Girls'*

- a. Under 12 competitions are self-graded (Kangaroos, Wallabies & Joeys Leagues).
- b. Leagues of no less than six (6) Teams or greater than 17 Teams may be created in Kangaroos, Wallabies or Joeys Leagues.
- c. If there are less than six (6) Teams in a Wallaby League it may be amalgamated with a corresponding Joeys League in that zone, or if there is no Joeys League for that zone, the Kangaroos League for that zone.
- d. If there is less than six (6) Teams in a Joeys league it may be amalgamated another league as per Rule 20.1.4 or at FV's absolute discretion.
- e. At FV's absolute discretion, more than 10 teams may be allocated into a Junior "Kangaroos" League and take into consideration one of the following structures.
 - (i) Regular season fixtures may be fixtures in Catch Up Rounds therefore increasing the number of games played. For example, 12 team structure will be played across 22 Rounds.
 - (ii) Regular season fixtures may be played on a double weekend (Saturday fixture) and/or midweek to ensure a balanced league amongst Under 12 Kangaroos competitions.
 - (iii) Introduce a league split during the season, which will see teams split once each team plays each other once in the first half of the season. In the second half of the season, teams will then be split into top half and bottom half and play each team in their half, based on their standings.

20. COMPETITION STRUCTURE

20.6.4. Boys & Girls Under 13 to Under 21s

- a. Excluding "A" league Competitions, the Top two (2) teams from each League of the previous season may be promoted to the next highest league in the next available age group for the following season.
- b. For all Competitions, the Bottom two (2) teams from each League of the previous season may be relegated to the next lowest league in the next available age group for the following season.
- c. At FV's discretion, more than 10 teams may be allocated into a Junior "A" League and take into consideration one of the following structures:
 - (i) Regular season fixtures may be fixtures in Catch Up Rounds therefore increasing the number of games played. For example, 12 team structure will be played across 22 Rounds.
 - (ii) Regular season fixtures may be played on a double weekend (Saturday fixture) and/or midweek to ensure a balanced league amongst 'A' competitions.
 - (iii) Introduce a league split during the season, which will see teams split once each team plays each other once in the first half of the season. In the second half of the season, teams will then be split into top half and bottom half and play each team in their half, based on their standings.
 - (iv) Leagues may remain unbalanced to ensure each team is playing the same amount of games. This may lead to clubs not having the opportunity to play against all opposition team an even number of times.
- d. In all grades other than "A", Leagues of no less than six (6) Teams may be created. If there are less than six (6) Teams in a League, that League may be amalgamated with another league as per Rule 20.1.4 or at FV's absolute discretion.

20.6.5. In Under 13 Boys Leagues, Clubs may have more than one (1) Team in "A".

20.6.6. In Under 14 to Under 21 Boys Leagues, Clubs may have no more than two (2) Teams in "A", unless "A" is the only League in that age group. Clubs may have single or multiple Teams in any League lower than "A".

20.6.7. All Teams will be graded having regard to Clubs who wish to request to be graded into a particular league must complete a League Request which FV will consider the following and referred to in Rule 20.6.4;

- a. A new club that did not compete in the previous season.
- b. A team that has registered a number of new players to the club that have previously played in "A" League Competition from the previous season.
- c. A team that finished in the bottom two (2) positions of the previous season however were competitive at the level.
- d. A team that finished 3rd position in the "B" League the previous season however demonstrate they were competitive.
- e. Other factors which may be considered at FV's discretion.

20.6.8. Age groups with one standalone division are considered an "A" League for the purpose of Rule 20.6.1.

20. COMPETITION STRUCTURE

20.7. Regrading & Late Team Entries

- 20.7.1. Following the conclusion of Round 4 of the Regular Season, a request to re-grade to a new League may only be considered by FV if:
- a. the League to which the team wants to move contains a bye (i.e., an uneven number of teams); and
 - b. the league from which the team wants to move does not contain a bye (i.e., an even number of teams); OR
 - c. there is a concurrent request from a Team to move between the two Leagues referred to in Rules 20.6.1.a. and 20.6.1.b. above which would effectively result in a direct swap between the two Teams in question and, therefore, no disruption to either of the respective leagues.
 - d. The team is not in a junior boys or girls 'A' competition or Under 12 Kangaroos competition

FV reserves the right to action a mandatory regrade based on the facilitation of a direct swap between two Leagues.

Once the season has commenced, if in the situation multiple requests to move into the same league are received, the regrade priority will be given based on results and standings.

- 20.7.2. No Club shall have more than two (2) Teams re-graded in the same competition age group except in extraordinary circumstances as deemed necessary by FV.
- 20.7.3. FV may consider a request to re-grade which does not satisfy the criteria stipulated in Rule 20.7.1 above in exceptional circumstances. In doing so, it will give consideration to the following:
- a. The extent of League and fixture disruption for other Teams caused by the proposed move.
 - b. Match results recorded between Rounds 1-4 of the current Regular Season. No request to re-grade will be considered if a Team has not won or lost all four fixtures.
 - c. History of the Team's performance across previous seasons.
 - d. Any additional information sought or requested by FV, including but not limited to referee and opposition feedback.
 - e. FV at its discretion may consider regrading a team between geographical zones
- 20.7.4. The following match determinations will apply to competitions affected by an approved request to re-grade in:
- a. Any re-graded Team will commence in its new League in Round 5.
 - b. Results and ladders for the regraded impacted league will be reset and previous results accounted for as 'grading games'.

20. COMPETITION STRUCTURE

- 20.7.5. The following match determinations will apply to competitions affected by an approved request to re-grade out:
- All championship points along with goals scored (for & against) for that Team will be erased.
 - If the affected competition comprises of an uneven number of Teams a 'BYE' will be inserted into the fixture to replace the regraded-out Team.
- 20.7.6. For avoidance of doubt where a competition is affected by both a Team re-grade out and a separate Team re-grade in, rule 20.7.4 will apply.
- 20.7.7. The Re-grading Period will commence following Round 4 of the Regular Season. All re-grading requests must be received by FV no later than 24 hours after the conclusion of a Team's Round 4 Competition Fixture. Any request received after this time will not be considered unless, in the opinion of FV, the request benefits all affected Leagues.
- 20.7.8. All regrading requests must be submitted through the online form which can be found on the FV Website. One form will be required for each re-grading request that is submitted. Requests for re-grading or confirmation sought over the phone or via email will not be considered by FV.
- 20.7.9. FV will act in its absolute discretion regarding regrading requests. All decisions are considered final.

20.8. Team Entry

- 20.8.1. Junior Boys Clubs that participated in the 2022 season, are required to Accept or Reject their respective Under 14 – Under 21 teams during the 2023 Team Entry Period as communicated by FV.
- 20.8.2. Junior Boys Under 12 and Under 13 competitions team entries are to be submitted as new team entries.
- 20.8.3. Clubs may apply to enter any number of Teams, new or existing, in any one (1) age group.
- 20.8.4. Any Club entering a new Team in Junior Boys' competitions (Under 13 to Under 21) must submit a league request during the team entry period stating the highest league the team is wishing to be allocated to. In the situation no request has been submitted, the team will be allocated at FV's discretion.
- 20.8.5. *Junior Girls 'Team Entry*
- Clubs may apply to enter any number of Junior Girls' Teams, in any one (1) age group.
 - Junior Girls teams (Under 12 – Under 19) are to be entered as new team entries.
 - Any Club entering a Team in Junior Girls' competitions (Under 12 to Under 19), will be considered by FV, taking into consideration the following:
 - the league standings and results from the previous season in the particular and subsequent age group; and
 - the composition of team entries received for a particular league and or age group.

- 20.8.6. Any online Team application submitted after the closure of the Team entry period will only be accepted if a vacancy exists within that age group, preferably in the club's rightful FV zone, however inclusion in another zone may be considered. Placement preferences will not be considered when allocating late Team entries.
- 20.8.7. Further to Rule 20.7.3, if a vacancy does not exist, FV will consider entering a 'late' Team following the regarding process which follows Round 4.
- 20.8.8. Where a late Team entry is accepted by FV and that Team commences in a League after the commencement of the Regular Season, FV will determine the allocation of Forfeits for the number of Competition Fixtures missed by that Team (as a result of late inclusion in the League in question) at its absolute discretion.

21. FIXTURE REQUIREMENTS

21. FIXTURE REQUIREMENTS

21.1. Interchange

- 21.1.1. Interchange Rule – Boys' Under 12 to Under 21 competitions and Girls' Under 12 to Under 19 competitions:
- For Under 12 – Under 13 a maximum of fourteen (14) players can be named on the Match Record. Clubs may make any number of interchanges during the course of the Competition Fixture, provided the Match Official has been consulted first and permits the substitution.
 - For Under 14 – Under 21 a maximum of seventeen (17) players can be named on the Match Record. Clubs may make any number of interchanges during the course of the Competition Fixture, provided the Match Official has been consulted first and permits the substitution.
 - A Match Official may decline the interchange of players in the last five (5) minutes of the second half of a Competition Fixture if in his or her opinion the change is being made to deliberately delay play.

21.2. Additional Time

- 21.2.1. Additional time shall not be played in Metropolitan Junior Competition Fixtures.

21.3. Match Balls

- 21.3.1. The following ball sizes apply:

- 21.3.2. The Home Club shall provide the appointed Match Official with 3 match balls of the appropriate size for that age group no later than 30 minutes prior to the start of the scheduled Competition Fixture.
- 21.3.3. All Clubs must use a licensed match ball from one (1) of FV's licensed ball manufacturers as advised by FV from time to time.
- 21.3.4. Any breach of the match ball licensing arrangements must be reported to FV by the Match Official.

21.4. Results of Competition Fixtures

Junior Competitions – Minimum Requirements

- 21.4.1. The Home Team must submit the Full Time Score.
- 21.4.2. All results for Sunday Competition Fixtures that kick off before 3.30pm shall be submitted online by the Home Club by 6.00pm that day.
- 21.4.3. For non weekend Competition Fixtures and Competition Fixtures that kick off after 3.30pm on a Sunday, the Home Club must enter the results by 9.00am on the day following the Competition Fixture.
- 21.4.4. All Competition Fixture results must be submitted via GameDay.
- 21.4.5. Clubs which fail to submit Competition Fixture results in accordance with Rule 21.3 may be penalised under the GDT.

22. JUNIOR FINALS SERIES

22. JUNIOR FINALS SERIES

22.1. Results of Competition Fixtures

- 22.1.1. Subject to this rule and unless otherwise determined by the FV Competitions Team the Teams that are eligible for finals of their respective League at the conclusion of the Regular Season may progress to a Final Series.
- 22.1.2. Final Series for junior competitions will be structured depending on the number of Leagues in a particular age group and grade. One of the following formats may be applied:
 - a. **Elimination Finals Format**; for example:
 - (i) If there are two (2) Leagues in a particular age and grade level across all zones, the Premiers of the two (2) respective Leagues will play each other in a one off Grand Final; or
 - (ii) there are four (4) Leagues in a particular age and grade level across all zones, the Premier of each League will be fixtured in a Semi Final/Grand Final Format; or
 - (iii) If there is a Standalone League (i.e., there is only one League in a particular age and grade level across all zones), the top four (4) Teams from that League at the end of the Regular Season will be fixtured in a Semi Final/Grand Final Format.
 - b. **Round Robin Finals Format**; for example if there are three (3) or five (5) Leagues in a particular age and grade level across all zones, the Premier of each League will be fixtured in a single Round Robin format where each Team plays each other once, the highest placed Team following the round robin series being crowned overall Premier.
 - c. **Pool Finals Format**; for example if there are six (6), seven (7), eight (8) or nine (9) Leagues in a particular age and grade level across all zones, the Premiers of each League will be allocated into separate pools, with a finals series played within and between those pools over a two (2) week period.
- 22.1.3. Details of each Finals Series format for all junior competitions and Leagues will be released by FV prior to the conclusion of the Regular Season.
- 22.1.4. FV may alter finals series formats as it deems necessary and acting in its absolute discretion.
- 22.1.5. If any 2023 Junior Finals Series Competition Fixture is postponed, abandoned or cancelled, that Final will be replayed at a time and venue to be determined by FV.
- 22.1.6. Each Club/Team will be required to pay 50% of the Match Official fee for each Final in which the Club/Team participates.
- 22.1.7. FV representative Teams participating in any FV Junior Competitions shall not be eligible to participate in any Junior Finals series. If a FV representative Team finishes the Regular Season in a position which qualifies it for a Finals series, it will be replaced in that Finals series by the next highest Team in its League (based on end of Regular Season ladder position).

22. JUNIOR FINALS SERIES

22.2. Procedures to Determine the Winner of Finals

- 22.2.1. All Competition Fixtures played in the 2023 Junior Finals Series will be played over one (1) leg.
- 22.2.2. If, at the conclusion of an Elimination Finals fixture, the scores between the Teams are tied, extra time of two equal periods will be used to decide the winner. Should the scores be level at the end of extra time penalty kicks will be taken in accordance with the IFAB Laws of the Game to determine the winner of the Final.
- 22.2.3. If, at the conclusion of a Round Robin or Pool Finals Format Fixture, the scores between the Teams are tied after regular time, penalty kicks will be taken in accordance with the IFAB Laws of the Game to determine the winner of the Final.
- 22.2.4. Subject to this rule and unless otherwise determined by the FV Competitions Team the Team which wins a Grand Final or a Pool Finals Format or Round Robin Finals Format competition may become the 2023 Champion of that age group Division for that season. For the avoidance of doubt simply winning the final does not entitle the Team to be named Champions.
- 22.2.5. Where two (2) or more Teams are tied following a Round Robin or Pool Finals Format, the top placed Team will be determined in accordance with results from the Finals series in question (including goals scored for and against). Specific details of the ranking system to be adopted in this regard will be released by FV prior to the conclusion of the Regular Season.

22.3. Discipline

- 22.3.1. All Suspensions from the Regular Season will carry over to the Junior Finals Series.
- 22.3.2. A player that receives a Red Card during the Junior Final Series will automatically miss the next Competition Fixture (whether or not that fixture is a Final) and may be subject to further sanction in accordance with the GDT.

22.4. Player Restrictions

- 22.4.1. Each player must have played at least five (5) Competition Fixtures for that Team during the current Regular Season to qualify for a Junior Finals series in the same year for that Team.
- 22.4.2. FV will only consider an exception to Rule 22.4.1 in exceptional circumstances and where a Club/Team can establish that it is unable to field a Team for a Final (in compliance with Rule 22.4.1) due to insufficient player numbers as a result of availability (including injury). Any Club wishing to rely on Rule 22.4.2 must apply to FV:
 - a. in writing;
 - b. at least five (5) days before the Final is due to take place;
 - c. setting out the reasons it requests an exception be granted to Rule 22.4.1, providing evidence in support of player unavailability; and
 - d. provide FV with any further information required.
- 22.4.3. FV will consider any request made in accordance with Rule 22.4.2 together with all information provided in support of that request and make a decision regarding any exception to Rule 22.4.1. Any decision made in this regard is at the sole and exclusive discretion of FV and is not subject to review or appeal.

23. COMPETITION STRUCTURE

23.1. General Information

- 23.1.1. These Regulations shall apply to all Metropolitan and Metropolitan Masters Competition Fixtures.
- 23.1.2. Subject to the Rules and Regulations at the end of the Regular Season, including any Finals or Play Off Matches, the final standings of each League may determine which Clubs are eligible to be promoted or relegated between Divisions. For the avoidance of doubt final standings of each League does not entitle the Team to promotion. There is no right to promotion.
- 23.1.3. All Metropolitan and Metropolitan Masters Teams will play each other on a home and away basis over 18 rounds unless otherwise determined by FV in its absolute discretion.

23.2. Metropolitan Competition

- 23.2.1. The Metropolitan competition shall comprise 15 Leagues across 8 Divisions as follows, or such other number as determined by FV at any time.

- 23.2.2. Number of teams is determined by FV in its absolute discretion.
 - a. FV will determine the structure of the leagues at their absolute discretion.
- 23.2.3. The Team finishing 1st in each of the Leagues referred to in Rule 23.2.1 at the conclusion of the Regular Season may be crowned the Premiers of that League and the 2nd placed Team may be the Runners-Up. For the avoidance of doubt the final standings of each League do not entitle the Team to be named Premiers or Runners Up.

23. COMPETITION STRUCTURE

- 23.2.4. All Teams will be graded having regard to their previous season’s standing and results, FV’s league request process and such other criteria as FV shall publish from time to time.
- 23.2.5. Metropolitan Competition Fixtures will be played on either Friday, Sunday or Monday. FV may schedule Competition Fixtures on other days as it deems necessary and acting in its absolute discretion.
- 23.2.6. Friday or Monday night Competition Fixtures may not kick off earlier than 6.30pm or later than 8.30pm, unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 23.2.7. Metropolitan Competition Fixtures cannot be scheduled for a Friday or Monday night if the distance between the home venues of the two (2) Clubs exceeds 50km, unless agreed in writing by the two (2) Clubs or as determined by FV acting in its absolute discretion.
- 23.2.8. Sunday Competition Fixtures may not kick off earlier than 11.00am or later than 8.30pm, unless the Competition Fixture has been rescheduled in accordance with Rule 4.3.
- 23.2.9. The applicable kick off times for Sunday Competition Fixtures apply to any Competition Fixtures held on a public holiday.
- 23.2.10. Any online Team application submitted after the closure of the Team entry period (as advertised by FV) will only be accepted if a vacancy exists within the relevant League, or at the discretion of FV.
- 23.2.11. Where a late Team entry is accepted by FV and that Team commences in a League after the commencement of the Regular Season, FV will determine the allocation of Forfeits for the number of Competition Fixtures missed by that Team (as a result of late inclusion in the League in question) in its absolute discretion.

23.3. Metropolitan Masters League

- 23.3.1. The Metropolitan Masters competition shall consist of Leagues of between 6 and 15 Teams each, based on geographic location, or as otherwise determined by FV.
- 23.3.2. FV will determine the Metropolitan Masters League structures at their absolute discretion.
- 23.3.3. The Team finishing 1st in each of the Leagues at the conclusion of the Regular Season may be crowned the Premiers of that League and the 2nd placed Team may be the Runners-Up. For the avoidance of doubt the final standings of each League do not entitle the Team to be named Premiers or Runners Up.
- 23.3.4. Metropolitan Masters Competition Fixtures will be played on either Friday, Sunday or Monday. FV may schedule Competition Fixtures on other days as it deems necessary and acting in its absolute discretion.
- 23.3.5. Friday or Monday night Competition Fixtures may not kick off earlier than 6.30pm or later than 8.30pm, unless either Competition Fixture has been rescheduled according to Rule 4.3.
- 23.3.6. Metropolitan Masters Competition Fixtures cannot be scheduled for a Friday or Monday night if the distance between the home venues of the two (2) Clubs exceeds 50km, unless agreed in writing by the two (2) Clubs or as determined by FV acting in its absolute discretion.
- 23.3.7. Sunday Competition Fixtures may not kick off earlier than 11.00am or later than 8.30pm, unless either Competition Fixture has been rescheduled according to Rule 4.3.

23. COMPETITION STRUCTURE

- 23.3.8. The applicable kick off times for Sunday Competition Fixtures apply to any Competition Fixtures held on public holidays.
- 23.3.9. Any online Team application submitted after the closure of the Team entry period (as advertised by FV) will only be accepted if a vacancy exists within the relevant League, or at the discretion of FV.
- 23.3.10. Where a late Team entry is accepted by FV and that Team commences in a League after the commencement of the Regular Season, FV will determine the allocation of Forfeits for the number of Competition Fixtures missed by that Team (as a result of late inclusion in the League in question) in its absolute discretion.

23.4. Vacancies in Men’s Metropolitan Competitions

- 23.4.1. From time to time vacancies are created in Men’s Metropolitan League Division due to:
- b. clubs not accepting the opportunity to be promoted;
 - c. a Team withdrawing from a Division or League;
 - d. a Team being expelled from a Division or League;
 - e. a Team being deemed ineligible for promotion as a result of a breach of these Rules and/or Regulations;
 - f. a Team being relegated as a result of a breach of these Rules and Regulations; or
 - g. other reasons from time to time.
- 23.4.2. If a vacancy is created in a Men’s Metropolitan League Division prior to the commencement of the Regular Season (whether that vacancy is created during the previous Regular Season or in the ‘off-season’ prior to the commencement of the Regular Season in question), FV shall have absolute discretion when filling a vacancy. FV may choose to leave the vacancy and replace it with a bye, fill the vacancy as per Rule 23.4.4 or decide upon an alternate outcome at FV’s absolute discretion.
- 23.4.3. If a vacancy is created in a Men’s Metropolitan League Division prior to the commencement of the Regular Season (whether that vacancy is created during the previous Regular Season or in the ‘off-season’ prior to the commencement of the Regular Season in question), that vacancy may be offered to Clubs in accordance with the priority set out in Rules 23.4.4 and 23.4.5.
- 23.4.4. Vacancies created in accordance with Rules 23.4.1 and 23.4.2 may be filled in the following order of priority:
- a. the highest finishing Team which is to be, or has been, relegated in accordance with these Regulations from the Division (refer to Rule 1.1.5h) in which the vacancy arises;
 - b. remaining Teams which are to be, or have been, relegated in accordance with these Regulations from the Division in which the vacancy arises in order of merit;
 - c. the highest finishing Team which misses out on promotion in accordance with these Regulations, from the Division below the Division in which the vacancy arises; and
 - d. remaining Teams which miss out on promotion in accordance with these Regulations, from the Division below the Division in which the vacancy arises in order of merit.

COMPETITION REGULATIONS

23. COMPETITION STRUCTURE

- 23.4.5. In deciding on order of merit for the purposes of Rule 23.4.4 or where two Teams are otherwise equal for the purposes of Rule 23.4.4, those Teams will be ranked according to the following (and in this order):
- a. league finishing position for respective teams;
 - b. average points per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - c. average Goal Difference per game for the current regular season (i.e. the season before the regular season in which the vacancy needs to be filled);
 - d. average goals FOR per game for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled);
 - e. the Team and the Club's disciplinary record for the current Regular Season (i.e. the season before the Regular Season in which the vacancy needs to be filled).
- 23.4.6. If Teams cannot be separated under Rule 23.4.5 then those Teams may be required to play a Play Off Match in circumstances where they both seek promotion to the higher Division in question.
- 23.4.7. FV, acting in its absolute discretion, may decide not to fill a vacancy in Men's Metropolitan League competition where to do so would disrupt lower Leagues and Divisions, for example where a League vacancy is created in close proximity to the start of the relevant Regular Season.

23.5. Player Restrictions

Metropolitan League

- 23.5.1. No more than two (2) players who have played in their Club's Men's State League Team (seniors or reserves) on any given weekend may play in a Metropolitan Competition Fixture that weekend.
- 23.5.2. On a weekend where a Club's Men's State League Team (seniors or reserves) is not scheduled to play in a Competition Fixture, no more than two (2) players who have Played in the Club's most recent Men's State League fixture will be eligible to play in a Metropolitan Competition Fixture that weekend.
- 23.5.3. If a Club has two or more Teams in the same League (of a particular Division) then players are 'team-tied' following completion of the sixth (6th) round of the Regular Season to one of those Teams. Clubs will be required to submit a Team list for each Team for Round 7 onwards, listing each player, which will be tied to that particular Team for the remainder of the Regular Season, with the following exemption for team-tied players:
- a. Up to a maximum of three (3) players listed to a particular Team may play for the Clubs other Team(s) in that League on any given weekend.
- 23.5.4. Further to Rule 23.5.3 any new player(s) that registers to a Metropolitan League Team after the sixth (6th) round of the Regular Season and is to play for a Club that has two Teams in the same league or Division, the club must allocate the player to one of the Team lists and that player will be tied to that Team for the remainder of the Regular Season (subject to the exceptions listed in Rule 23.5.3.a above).

23. COMPETITION STRUCTURE

- 23.5.5. Where a Club has multiple teams in different Metropolitan Leagues/Divisions (i.e. a team in Metropolitan League 5 and Metropolitan League 2), once a player has played six (6) or more Competition Fixtures for the Team entered by his Club in the higher Division of Metropolitan League, that Player is team-tied to the higher Division Team, with the following exemption:
- a. Up to a maximum of three (3) players who have played six or more Competition Fixtures for the higher Division Metropolitan League Team may play for the Club’s other lower Division Team(s) on any given weekend.
- 23.5.6. To be eligible to participate in Metropolitan League competitions, players must be 15 years (or older) as at 1 January 2023 unless an application to FV for exemption from Rule 23.5.6 is made by the player’s Club on behalf of a player and is approved by FV.
- 23.5.7. An application made under Rule 23.5.6 must meet the following minimum criteria:
- a. The application must be supported by a signed letter from the player’s Club president supporting the application;
 - b. The application must be supported by a signed letter from the player’s State Team/Representative Team coach or Club Technical Director;
 - c. The application must be supported by a signed letter of consent from the player’s parent or guardian supporting the application;
 - d. The application must be supported by a signed letter of support from the player’s medical professional listing general medical details of the player including height and weight and;
 - e. The Club/player must provide FV with any further information requested.
- 23.5.8. An application made under Rule will be considered by the FV. FV has absolute discretion in relation to any application made under that Rule.

Metropolitan Masters League

- 23.5.9. All players must be 35 years or older as at 1 January 2023, unless an application to FV for exemption from Rule 23.5.9 is made through the [FV Dispensation Policy](#) regulations by the player’s Club on behalf of a player and is approved by FV.
- 23.5.10. No more than two (2) players who have played in their Club’s Men’s State League Team (seniors or reserves) on any given weekend may play in a Metropolitan Masters Competition Fixture that weekend.
- 23.5.11. On a weekend where a Club’s Men’s State League Team (seniors or reserves) is not scheduled to play in a Competition Fixture, no more than two (2) players who have Played in the Club’s most recent Men’s State League fixture will be eligible to play in a Metropolitan Masters Competition Fixture that weekend.

24. FIXTURE REQUIREMENTS

24. FIXTURE REQUIREMENTS

24.1. Interchange

Interchange Rule – Metropolitan and Metropolitan Masters Leagues

- 24.1.1 A maximum of seventeen (17) players may be named on the Match Record. Clubs may make any number of interchanges during the course of the Competition Fixture, provided the Match Official has been consulted first.
- 24.1.2 A Match Official may decline the interchange of players in the last five (5) minutes of the second half of a Competition Fixture if in his or her opinion the change is being made to deliberately delay play.
- 24.1.3 All substitutes must be seated within the Technical Area.

24.2. Additional Time

- 24.2.1. Additional time for Men's Metropolitan and Masters must be played in accordance with the IFAB Laws of the Game.

24.3. Match Balls

- 24.2.1. The Home Club shall provide the appointed Match Official with 3 match balls of the appropriate size for that age group no later than 30 minutes prior to the start of the scheduled Competition Fixture.
- 24.2.2. All Clubs must use a licensed match ball from one (1) of FV's licensed ball manufacturers as advised by FV from time to time.
- 24.2.3. Any breach of the match ball licensing arrangements must be reported to FV by the Match Official.

24.4. Results of Competition Fixtures

Metropolitan and Metropolitan Masters Leagues – Minimum Requirements

- 24.3.1. The Home Team must submit the Full Time Score.
- 24.3.2. All results for Sunday Competition Fixtures that kick off before 3.30pm shall be submitted online by the Home Club by 6.00pm that day.
- 24.3.3. For non weekend Competition Fixtures and Competition Fixtures that kick off after 3.30pm on a Sunday, the Home Club must enter the results by 9.00am on the day following the Competition Fixture.
- 24.3.4. All Competition Fixture results must be submitted via GameDay.
- 24.3.5. Clubs which fail to submit Competition Fixture results in accordance with Rule 24.3 may be fined or penalised under the GDT.

- 25.1.1. Admittance to all Metropolitan and Metropolitan Masters Regular Season and Finals Competition Fixtures is free of charge, including car parking.

26. FINALS SERIES

26. FINALS SERIES

26.1. Metropolitan Competition Finals Format

- 26.1.1. All Metropolitan competitions may conclude the Regular Season with a Finals series.
- 26.1.2. Subject to this rule and unless otherwise determined by the FV Competitions Team the Teams that finish top four (4) Teams in Metropolitan League 1 at the conclusion of the 2023 Regular Season may progress to the 2023 Metropolitan League 1 Finals Series
- 26.1.3. The format of the 2023 Metropolitan League 1 Finals Series may be as follows:

Week 1

Semi Final 1: 1st v 4th

Semi Final 2: 2nd v 3rd

Week 2

Grand Final: Winner Semi Final 1 v Winner Semi Final 2

- 26.1.4. The Teams which finish in 1st and 2nd positions in Metropolitan League 1 at the conclusion of the 2023 Regular Season shall be entitled to host their Week 1 Semi Final at their home venue. The Grand Final will be played at a neutral venue to be determined by FV.
- 26.1.5. If the nominated venue(s) for Week 1 of the 2023 Metropolitan League 1 Finals Series is/are deemed unfit for play, alternative venues will be determined at the absolute discretion of FV.
- 26.1.6. The Home Club will cover all Match Official match fees in Week 1 of the 2023 Metropolitan League Finals Series.
- 26.1.7. FV will cover all Match Official match fees in Week 2 of the 2023 Metropolitan League 1 Finals Series.
- 26.1.8. The Premier of Metropolitan League 2 South-East may play the Premier of Metropolitan League 2 North-West to determine the Metropolitan League 2 Champion.
- 26.1.9. The Premier of Metropolitan League 3 South-East may play the Premier of Metropolitan League 3 North-West to determine the Metropolitan League 3 Champion.
- 26.1.10. The Premier of Metropolitan League 4 South-East may play the Premier of Metropolitan League 4 North-West to determine the Metropolitan League 4 Champion.
- 26.1.11. The Premier of Metropolitan League 5 South-East may play the Premier of Metropolitan League 5 North-West to determine the Metropolitan League 5 Champion.
- 26.1.12. The Premier of Metropolitan League 6 South-East may play the Premier of Metropolitan League 6 North-West to determine the Metropolitan League 6 Champion.
- 26.1.13. The Premier of Metropolitan League 7 South-East may play the Premier of Metropolitan League 7 North-West to determine the Metropolitan League 7 Champion.
- 26.1.14. The Premier of Metropolitan League 8 South-East may play the Premier of Metropolitan League 8 North-West to determine the Metropolitan League 8 Champion, unless there is only one (1) League in that Division, in which case Rule 26.1.3 will apply.

26. FINALS SERIES

- 26.1.15. All fixture dates and venues for the Metropolitan League Finals Series referred to in Rules 26.1.3 to 26.1.14 will be neutral and will be determined by FV acting in its absolute discretion.
- 26.1.16. Where a standalone Metropolitan League competition exists (below Metropolitan League 1), the finals series will be the same as that set out for Metropolitan League 1 in Rules 26.1.2 to 26.1.3 above.
- 26.1.17. The Metropolitan League finals structure is determined based on the team entries into the current league structures, should the league structures change based on team entries the finals series format may also be amended at FV's discretion.
- 26.1.18. Subject to this Regulation and unless otherwise determined by FV acting in its absolute discretion, the Team winning the Finals at the conclusion of the Regular Season may entitle the Team to be named Champions. For the avoidance of doubt simply winning the final does not entitle the Team to be named Champions.
- 26.1.19. Match Official match fees for Metropolitan Finals are to be shared by the two competing Clubs/Teams, unless one of the competing Clubs is the Host Club in which case the Host Club will pay the Match Official fees.

26.2. Metropolitan Masters Competition Finals Format

- 26.2.1. All Metropolitan Masters competitions may conclude the Regular Season with a Finals series.
- 26.2.2. Subject to this rule and unless otherwise determined by the FV Competitions Team the Teams that finish as Premiers of their regional Metropolitan Masters League at the conclusion of the Regular Season may progress to a Final Series
 - a. In the situation where three (3) Competitions exist, the highest placed runner up will be included in the Metropolitan Masters Finals Series as per the following criteria:
 - i. average points per game;
 - ii. average Goal Difference per game during the Regular Season;
 - iii. average Goals FOR per game during the Regular Season;
 - iv. the Team's Disciplinary record during the current Regular Season;
 - v. if Teams cannot be separated, then those Teams will be required to play a Play Off Match.
- 26.2.3. The four (4) Teams referred to in Rule 26.2.2 will be randomly drawn against an opponent for a semi-final in week 1 of the 2023 Metropolitan Masters Finals Series.
- 26.2.4. The winners of the semi-finals referred to in Rule 26.2.2 will compete in the 2023 Metropolitan Masters Grand Final.
- 26.2.5. Subject to this Regulation and unless otherwise determined by FV acting in its absolute discretion, the Team winning the Finals at the conclusion of the Regular Season may entitle the Team to be named Champions. For the avoidance of doubt simply winning the final does not entitle the Team to be named Champions.
- 26.2.6. All venues for the Metropolitan Masters Finals Series will be neutral and will be determined by FV at its discretion.

26. FINALS SERIES

- 26.2.7. Match Official match fees for Metropolitan Masters Finals are to be shared by the two competing Clubs/Teams, unless one of the competing Clubs is the Host Club in which case the Host Club will pay the Match Official fees.

26.3. Procedure to Determine the Winner of Finals

- 26.3.1. All Competition Fixtures played in the 2023 Metropolitan League and Metropolitan Masters League Finals Series will be played over one (1) leg.
- 26.3.2. If, at the conclusion of any Final, the scores between the Teams are tied, then extra time of two (2) equal periods of 15 minutes will be played in accordance with IFAB Laws of The Game.
- 26.3.3. If scores remain equal at the conclusion of both periods of extra time, penalty kicks will be taken in accordance with the IFAB Laws of the Game to determine the winner of the Competition Fixture.

26.4. Discipline

- 26.4.1. Yellow cards accumulated by a player during the Finals Series will not be counted for the purposes of clause 4.3.a of the GDT. However, if a player receives their 5th yellow card in their Team’s final Regular Season Competition Fixture they shall be suspended for the first applicable Final of the 2023 Finals Series.

26.5. Player Restrictions

- 26.5.1. Each player must have played at least five (5) Competition Fixtures for that particular Team during the current Regular Season to qualify for a Metropolitan or Metropolitan Masters Finals series in the same year for that Team.
- 26.5.2. FV will only consider an exception to Rule 26.5.1 in exceptional circumstances and where a Club/Team can establish that it is unable to field a Team for a Final (in compliance with Rule 26.5.1) due to insufficient player numbers as a result of availability (including injury). Any Club wishing to rely on Rule 26.5.2 must apply to FV:
- a. in writing;
 - b. at least 5 days before the Final is due to take place;
 - c. setting out the reasons it requests an exception be granted to Rule 26.5.1, providing evidence in support of player unavailability; and
 - d. provide FV with any further information required.
- 26.5.3. FV will consider any request made in accordance with Rule 26.5.2 together with all information provided in support of that request and make a decision regarding any exception to Rule 26.5.1. Any decision made in this regard is at the sole and exclusive discretion of FV and is not subject to review or appeal.

SCHEDULE 5 – CODES OF BEHAVIOUR

Overview

The following codes are deemed to be incorporated into these Rules of Competition:

- [FA National Code of Conduct and Ethics](#)
- [Victorian Code of Conduct for Community Sport \(Fair Play Code\)](#)
- It is vital that everyone involved in Football, whether they are athletes, coaches, parents, officials or supporters, understand their responsibilities to ensure that all participants enjoy the sport.
- It is strongly recommended that all players, parents, officials, coaches and members be given a copy of these codes by their Club, and that each Club ensures the codes are clearly displayed in their Clubrooms.
- As well as reading and seeking to understand the instructions contained in the codes, FV asks all participants to recognise that there are underlying principles which extend beyond those specific instructions.

General Principles for all Persons Involved in Sport

- Operate within the Rules and spirit of Football, promoting fair play over winning at any cost.
- Encourage and support opportunities for people to learn appropriate behaviours and skills.
- Support opportunities for participation in all aspects of the sport.
- Treat each person as an individual.
- Display control and courtesy to all involved with the sport.
- Respect the rights and worth of every person regardless of their gender, ability, cultural background or religion.
- Respect the decisions of officials, coaches and administrators in the conduct of the sport.
- Wherever practical, avoid unaccompanied and unobserved one-on-one activity (when in a supervisory capacity or where a power imbalance will exist) with people under the age of 18 years.
- Adopt appropriate and responsible behaviour in all interactions.
- Adopt responsible behaviour in relation to alcohol and other drugs.
- Act with integrity and objectivity, and accept responsibility for your decisions and actions.
- Ensure your decisions and actions contribute to a safe environment.
- Do not tolerate harmful or abusive behaviours.
- Do not bring the game of Football into Disrepute, by engaging in discriminatory, offensive or criminal behaviour.

SCHEDULE 5 – CODES OF BEHAVIOUR

- Ensure your decisions and actions contribute to a harassment free environment.
- Do not bring the game into Disrepute by engaging in harassment, including sexual harassment or any unwelcome sexual conduct which makes a person feel offended, humiliated and/or intimidated.
- Do not bring the game into Disrepute by provoking or inciting hatred or violence, including crowd violence.
- Do not bring the game into Disrepute by engaging in corruption, forgery or falsification, or by abusing a position to obtain a personal benefit.
- Do not bring the game into Disrepute by the throwing or fixing of a match, by accepting bribes, or by any conduct intended to unfairly effect the result of a match.
- Do not bring the game into Disrepute by any other conduct that materially injures the reputation and goodwill of Football.

(NB for the purposes of this code of behaviour 'Disrepute' means conduct, statement or appearance in public that is damaging to reputation).

Players' Code of Behaviour

- Give your best at all times.
- Participate for your own enjoyment and benefit.
- Play by the Rules.
- Do not argue with the Match Official. If you disagree, have your captain or coach approach the Match Official during a break in play or after the Match is concluded.
- Control your temper. Verbal abuse of officials or other players, deliberately distracting or provoking another person is not acceptable or permitted in any sport.
- Be a good sport and be prepared to acknowledge good play whether it is from your Team or the opposition.
- Treat all players as you would like to be treated. Do not interfere with, bully or take unfair advantage of another player.
- Co-operate with your coach, Teammates and opponents. Without them, there would be no competition.
- Remove all jewellery prior to training and Match play, as it is a hazard to you and those around you.
- Do not accept or use any banned or unauthorised drug(s), including the consumption of alcohol at any time.

SCHEDULE 5 – CODES OF BEHAVIOUR

Coaches' Code of Behaviour

- Place the safety and welfare of the participants above all else.
- Be aware of and support the sport's injury management plans and return to play guidelines.
- Help each person (athlete, official, etc) to reach their potential. Respect the talent, developmental stage and goals of each person and encourage them with positive and constructive feedback.
- Encourage and support opportunities for people to learn appropriate behaviours and skills.
- Support opportunities for participation in all aspects of the sport.
- Treat each participant as an individual.
- Obtain appropriate qualifications and keep up-to-date with the latest coaching practices and the principles of growth and development of participants.
- Act within the rules and spirit of your sport.
- Promote fair play over winning at any cost.
- Respect the decisions of officials, coaches and administrators.
- Show respect and courtesy to all involved with the sport.
- Display responsible behaviour in relation to alcohol and other drugs.
- Act with integrity and objectivity, and accept responsibility for your decisions and actions.
- Ensure your decisions and actions contribute to a harassment-free environment.
- Wherever practical, avoid unaccompanied and unobserved one-on-one activity (when in a supervisory capacity or where a power imbalance exists) with people under the age of 18.
- Ensure that any physical contact with another person is appropriate to the situation and necessary for the person's skill development.
- Be honest and do not allow your qualifications or coaching experience to be misrepresented.
- Never advocate or condone the use of illicit drugs or other banned performance enhancing substances or methods.
- Never participate in or advocate practices that involve match fixing.
- Respect the rights and worth of every person, regardless of their age, race, gender, ability, cultural background, sexuality or religion.
- Do not tolerate abusive, bullying or threatening behaviour.

SCHEDULE 5 – CODES OF BEHAVIOUR

Administrators' Code of Behaviour

- Act honestly, in good faith and in the best interests of the sport as a whole.
- Ensure that any information acquired or advantage gained from the position is not used improperly.
- Conduct your responsibilities with due care, competence and diligence.
- Do not allow prejudice, conflict of interest or bias to affect your objectivity.
- Help coaches and officials highlight appropriate behaviour and skill development, and assist in raising the standards of coaching and officiating.
- Ensure everyone involved in football emphasises fair play, and not winning at all costs.
- Be tolerant and calm under pressure and approach problem solving in a supportive manner as members and players will expect you to set an example for others.

Match Officials' Code of Behaviour

- Place the safety and welfare of the athletes above all else.
- Be consistent and impartial when making decisions.
- Address unsporting behaviour and promote respect for all people.
- Modify your approach to suit the skill levels and needs of players.
- Praise and encourage all participants.
- Be consistent, objective and courteous when making decisions.
- Do not tolerate unsporting behaviour and promote respect for all opponents.
- Emphasise the spirit of the game rather than focus on negative aspects.
- Encourage and promote rule changes to all players and members.
- Be a good sport yourself, as actions speak louder than words.
- Keep up to date with the latest trends in refereeing.
- Remember that you set the example on the park, therefore, your behaviour and comments should always be positive and supportive.

SCHEDULE 5 – CODES OF BEHAVIOUR

Parents Code of Behaviour

- Remember that children play the sport for their enjoyment, and not yours.
- Encourage children to participate and have fun.
- Focus on the child's effort and performance rather than winning or losing.
- Encourage children to always participate according to the rules.
- Never ridicule or yell at a child for making a mistake or losing a competition.
- Remember that children learn best by example, so applaud good play by both Teams.
- Support all efforts to remove racial and religious vilification, verbal and physical abuse from sporting activities.
- Respect the match official's decisions and teach your child to do likewise.
- Show respect and appreciation to Club officials, including coaches, officials and administrators. Ensure any issues are raised through the correct channels.
- Do not smoke or consume alcohol near the Team bench (Technical Area) or sideline.

Spectators' Code of Behaviour

All spectators must comply with the [FA National Spectator Code of Behaviour](#).

It is important that all spectators at a Football Federation Victoria (FV) approved fixture are able to enjoy the Match in a safe and comfortable environment. Accordingly, each person present at a FV fixture must:

- Respect the decisions of the Match Officials, and teach children to do the same;
- Never ridicule or unduly scold a child for making a mistake.
- Respect the rights, dignity and worth of every person regardless of their gender, ability, race, colour, religion, language, politics, national or ethnic origin; Not use violence in any form, whether it is against other Spectators, Team Officials (including coaches) or Players.
- Not engage in discrimination, harassment or abuse in any form including the use of obscene or offensive language or gestures, the incitement of hatred or violence or partaking in indecent or racist chanting.
- Comply with any terms of entry of a venue, including bag inspections, prohibited and restricted items such as flares, missiles, dangerous articles and items that have the potential to cause injury or public nuisance.
- Not display, or attempt to display, the following items within the Venue:
 - a. National, political or racial flags or emblems except for the recognised National flags of the competing teams;
 - b. Offensive or inappropriate banners in either English or a foreign language.

- Not throw missiles (including on to the field of play or at other spectators) and must not enter the field of play or its surrounds without lawful authority.
- Conduct themselves in a manner that enhances, rather than injures, the reputation and goodwill of FV, FA, and football generally.
- It is the host Club's responsibility to ensure this Spectator Code of Behaviour is implemented and enforced against all spectators.

Victorian Code of Conduct for Community Sport

Every person in Victoria has the right to participate in community sport that is safe, welcoming and inclusive. At the same time, everyone plays a part in ensuring their behaviour and their actions are supportive of these values.

State Sporting Associations, leagues and clubs also have a responsibility to ensure participation in any community sport event is free of any anti-social behaviour. This means that behaviour both on and off the field should not prevent others from taking part and getting active.

The [Victorian Code of Conduct for Community Sport \(Fair Play Code\)](#) outlines behaviours which are expected of every person involved in community sport, and behaviours which must not be tolerated.

The Code supports [Victoria's Strategy to Prevent Family Violence and all Forms of Violence Against Women](#) by taking a zero tolerance stance towards violence against women. The Code also aims to encourage cultural and behavioural change as a pre-emptive measure against violence.

Acts of [violence](#), [discrimination](#) and [vilification](#) are illegal acts in Victoria. It is a club's responsibility to report these to the appropriate legal authorities and ensure these acts are not tolerated by the sport or club.

State Sporting Associations, leagues and clubs will have the responsibility of adhering to and enforcing the code through sport specific penalties. Organisations that do not adhere to and enforce the Code will not be eligible for funding from Sport and Recreation Victoria, and any existing funding will cease.

The Code provides the opportunity to make a positive impact on community participation in sport and recreation by encouraging appropriate behaviour at all times. Implementation of the Code will ensure that community sport remains safe and inclusive for all.

Code of Conduct

Every person: spectator, player, club member, official, participant, administrator, coach, parent or member of the community involved with the sport, should work to ensure:

- inclusion of every person regardless of their age, gender or sexual orientation.
- inclusion of every person regardless of their race, culture or religion.
- opportunities for people of all abilities to participate in the sport and develop to their full potential.
- respect is shown towards others, the club and the broader community.
- a safe and inclusive environment for all.
- elimination of violent and abusive behaviour.

SCHEDULE 5 – CODES OF BEHAVIOUR

- protection from sexual harassment or intimidation.

This code applies to community sport, training and club sanctioned activities.

Breaches of the Code

The following behaviours are considered breaches of the Code:

- Violent or abusive behaviour towards another person.
- Vilification of any kind towards another person.
- Discrimination against another person based on their age, gender or sexual orientation.
- Discrimination against another person based on their race, culture, religion or any other irrelevant personal characteristic.
- Sexual harassment or intimidation of another person.
- Victimisation of another person for exercising their rights through the Code of Conduct.
- Failure to maintain a safe environment.

If any of these behaviours take place within a sport or recreational context, the relevant State Sporting Association, league, association or club is able to impose penalties or sanctions. For this to occur, the breach must be confirmed through an appropriate assessment process at the appropriate level.

State Sporting Association Responsibility

The responsibility of a State Sporting Association through the Code of Conduct is to:

- promote the Code of Conduct to all persons involved in the sport or club.
- ensure reporting and assessment processes are in place to identify and penalise breaches of the Code.
- report on the implementation of the Code to the State Government on an annual basis.
- ensure that every person involved in the sport is able to exercise their rights without fear of victimisation.
